On 2/26/2015 at approximately 1700 hours, Officers saw Ron Fulgencio, age 65, and AJ Stovall, age 54, sitting at a borough bus stop on the 300 block of Stedman Street and noticed both males had open beer cans next to them. The males were charged with Disorderly Conduct – Open Container. Both were transported to the State Jail and later released on their own recognizance.

On 02/27/2015 at approximately 2200 hours, Officers served Alex Brown, age 41, a summons for Theft in the Second Degree. The charges stem from an investigation in which Mr. Brown is alleged to have been in possession of a stolen firearm.

On 2/27/2015 at approximately 2302 hours, Officers responded to a residence on Baranof Avenue due to a report from Denise Olofson, age 25, that an intoxicated male was trespassing at the location. The investigation revealed Ms. Olofson assaulted a male subject in the residence with whom she had a domestic relationship. Ms. Olofson was subsequently arrested for Assault in the Third Degree Domestic Violence based on her having two prior convictions of Assault in the Fourth Degree within the past ten years in the State of Alaska. She was transported to the State Jail and held without bail.

On 2/28/2015 at approximately 2356 hours, Officers responded to the 300 block of Edmonds Street for an unrelated matter. Upon arrival Officers contacted Jason Brendible, age 18, sleeping on the side of the road and who appeared to be intoxicated. Mr. Brendible is on felony probation with conditions not to consume alcohol. Mr. Brendible was arrested for the probation violation and lodged at the State Jail and held without bail. He was additionally cited for Possession of Alcohol by Minor.

On 3/1/2015 at approximately 1412 hours, Officers contacted Michalyn McAlpin, age 48, in the 600 block of Dock Street. She was subsequently arrested for an outstanding warrant. She was transported to the State Jail and held on \$1000.00 bail.

On 3/1/2015 at approximately 2210 hours, Officers responded to a local hotel due to a report that a female was having trouble breathing. Melissa Charles, age 22, was found to be under the influence of narcotics. Officers conducted multiple Search Warrants on her hotel room. Officers seized a total of 8.3. grams of Methamphetamine, .35 grams of heroin, \$700.00 in U.S. Postal Money Orders and \$1713.00 in cash. Ms. Charles was charged with Misconduct Involving a Controlled Substance in the Second Degree, Misconduct Involving a Controlled Substance in the Third Degree and Misconduct Involving a Controlled Substance in the Fourth Degree. She was transported to the State Jail and held without bail.
