On 7/18/18 at approximately 2012 hours, Officers contacted Monika R. Haven, age 21, in the 300 block of Bawden Street. She was served a summons ordering her to appear in court. The summons was issued after an investigation was completed concerning a glass entry door being shattered at a downtown apartment complex.

On 07/18/18 at approximately 2233 hours, Officers contacted Mark F. Romine, age 36, in the 600 block of Jackson Street during a traffic stop. He was arrested on two outstanding warrants. He had failed to report to the Ketchikan Correctional Center to serve court ordered time. He was transported to the state jail and held on no bail.

On 7/21/18 at approximately 0203 hours, Officers contacted Cynthia Bean, age 44, in the 300 block of Front Street due to her yelling obscenities loudly, disturbing the peace of others in the area and attempting to assault an unknown male. Ms. Bean was verbally warned for Disorderly Conduct - Loud Noise. Ms. Bean continued yelling obscenities loudly. She was placed under arrest for Disorderly Conduct and transported to the state jail where she was set to be released on her own recognizance.

On 7/21/18 at approximately 0830 hours, Officers contacted Kenneth C. Del Mundo, age 23, at 2415 Hemlock Avenue #705. Mr. Del Mundo was served a summons to appear in court. The charge is related to a case earlier this month.

On 07/21/18 at approximately 0948 hours, Officers responded to the 1600 block of Tongass Avenue due to a report of an assault. Officers contacted Gary A. Ward, age 58. After the investigation, he was arrested for Assault in the Fourth Degree Domestic Violence. He was transported to the state jail where he was held on no bail.

On 07/21/18 at approximately 1834 hours, Officers conducted a traffic stop in the 700 block of Deermount Street. The driver, Shelly A. Laroussi, age 56, was contacted and arrested for Violation of Conditions of Release. She had been court ordered not to drive unless validly licensed. She was additionally charged with Driving While License Revoked. She was transported to the state jail and held on \$250.00 bail.

On 07/22/18 at approximately 1820 Hours, Officers contacted Anthony P. Charles, age 34, and another male in an altercation in the 300 block of Front Street. Mr. Charles had been consuming alcohol in violation of his court ordered conditions. He was arrested for Violation of Conditions of Release, transported to the state jail and held on \$250.00 bail.

On 7/22/18 at approximately 0237 hours, Officers conducted a traffic stop on a red pickup for reckless driving. Officers contacted Jose M. Roman age 43, who appeared intoxicated. He failed standardized field sobriety tests and was arrested for Driving Under the Influence. He was transported to the state jail and set to be released on his own recognizance.
