On August 27, 2013 at approximately 6:00 PM Officers responded to a west end business due to a report of a shoplifter in custody. Upon investigation it was learned Rebecca M. Tyler, age 25 of Ketchikan, stole approximately \$178.26 worth of merchandise. She was issued a citation for Theft in the Third Degree.

On August 29, 2013 at approximately 6:49 PM a person bought several items to the police department they believed were stolen. The items were linked to several thefts from unlocked vehicles in the Bear Valley area including two rifles. Through the investigation an arrest warrant was issued for David M. Patchanian, age 24 of Ketchikan. He was arrested with the assistance of the Airport Police. He was transported to the Ketchikan Correctional Center and held on \$10,000.00 bail.
