On 7/21/12 at approximately 0132 hours, officers received a report of JUAN J. RANGEL, JR., 38 years of age, of Ketchikan, Alaska, driving a white 1992 Chevrolet van was violating conditions of release by having contact with the female passenger and that he was under the influence. Officer conducted a traffic stop Mr. Rangel was arrested for Violation of Conditions of Release. He was transported to the Ketchikan Correction Center and held on \$500.00 bail.

On 7/21/12 at approximately 0301 hours, while parked at the intersection of Madison Street and Fourth Avenue, officers observed a gray 1997 Ford F-150 pickup miss side-swiping the patrol vehicle and parked car while traveling west on Fourth Avenue.
