On 6/19/12 at approximately 2256 hours, officers responded to the 900 block of Park Avenue due to a report of a male holding a female against her will. Officers interviewed a female who stated that DONALD R. DOYON, 26 years of age, of Ketchikan, Alaska, struck her open handed on the left side of her face causing injury and her ears to ring, choked her with both hands until she felt a tingling sensation, had difficulty breathing and felt like she was going to pass out, ripped her camisole, purse and bra off causing injury to her shoulder, he grabbed her cell phone away from her so she couldn't call the Police, blocked her way so she couldn't leave the bedroom, she was able to get away by diving out the bedroom window causing injury to her knee . Upon investigation Mr. Doyon was arrested for Assault in the Third Degree-Domestic Violence and Interfering with a Report of a Crime Involving Domestic Violence. He was transported to the Ketchikan Correctional Center and held without bail.

On 6/20/12 at approximately 0222 hours, officers were dispatched to the 700 block of Harris Street due to a report of two males in a physical altercation. Upon investigation officers arrested ALEXANDER D. ORR, 22 years of age, of Ketchikan, Alaska for Assault in the Fourth Degree-Domestic Violence. He was transported to the Ketchikan Correctional Center where he was held with no bail.

On 6/21/12 at approximately 1434 hours, officers responded to Walmart due a report of theft. Upon investigation TAYLOR R. BURKHART 18 years of age, of Ketchikan, Alaska, was arrested for Theft in the Third Degree.

On 6/21/12 at approximately 1948 hours, officers observed three adults in the 600 block of Dock Street. Officers made contact with TED R. GLASSER 44 years of age, and MARGARET L. HAMILTON, 65 years of age of Ketchikan Alaska, sitting on one of the benches with a can of beer in his hand. Mr. Hamilton was arrested for Disorderly conduct – Open Container and Violation of Conditions of Release. He was transported to the Ketchikan Correctional Center where he was set to be released on his own recognizance for the Disorderly Conduct – Open Container charge but held on \$500.00 bail for the Violation of Conditions of Release charge.

On 6/23/12 at approximately 0039 hours, while on vehicle patrol in the 600 block of Water Street, officers were flagged down by concerned citizens who pointed out a female sitting on the curb crying. Officers made contact with CHRISTINE L. BRENDIBLE 24 years of age, of Ketchikan, Alaska, who had a strong order of intoxicants on her breath. Ms. Brendible became violent trying to hit officers. She was arrested for Disorderly Conduct and transported to the Ketchikan Correctional Center where she was set to be released on her own recognizance.

On 6/24/12 at approximately 0151 hours, officers conducted a traffic stop in the 500 block of Water Street on a black 1998 Toyota pickup due to a defective tail light. NICHOLE M. VEST, 21 years of age, of Ketchikan, Alaska, was arrested for Parole Violation. She was transported to the Ketchikan Correctional Center and held on no bail.

On 6/24/12 at approximately 1426 hours, officers responded to Residential Youth Care Facility due to a report of a possible assault between two male juveniles. Officers interviewed the two male juveniles. A 15 year old male juvenile was arrested for Assault in the Fourth Degree – Domestic Violence.

Officers made contact with the female who stated CHRISTOPHER J. HILL, 24 years of age, of Ketchikan, Alaska, came to pick up their daughter who was sleeping. The female asked Mr. Hill to come back later, he became upset and refused to leave, the female forced him out of the residence, he blocked the door open with his foot and forced it open causing the female to fall backward over the arm of the couch she was placed in fear of being struck when Mr. Hill moved quickly

toward her with balled fists acting like he was going to strike her. Mr. Hill was arrested for Assault in the Fourth Degree – Domestic Violence and Criminal Trespass in the First Degree – Domestic Violence. He was transported to the Ketchikan Correctional Center and held without bail.

On 6/26/12 at approximately 0034 hours, officers conducted a traffic stop at the 2400 block of Sixth Avenue on a black 1997 Chevrolet truck due to a traffic violation. Upon investigation DANIEL S. On 6/28/12 at approximately 0832 hours, officers arrested DAYLON D. KROUT, 24 years of age, of Ketchikan, Alaska, on an outstanding warrant bail was set at \$2,500.00.

On 6/28/12 at approximately 2342 hours, while patrolling south on Schoenbar Road near the intersection of Water Street officers observed a black Ford Focus driving without headlights illuminated. The vehicle failed to stop at a stop sign and failed to use its turn signal. Officers conducted a traffic stop and made contact with SPENCER L. He was transported to the Ketchikan Correctional Center where he was set to be released on his own recognizance.
