

**PRESS RELEASE**

On 6/9/12 at approximately 0022 hours, officers contacted an intoxicated female who was causing a disturbance in the 1400 block of Tongass Avenue. Officers made contact with MONIKA D. KELLEY, 21 years of age, of Ketchikan, Alaska. Upon investigation she was arrested for Disorderly Conduct-Loud Noise. She was transported to the Ketchikan Correctional Center where she was set to be released on her own recognizance.

On 6/11/12 at approximately 1908 hours, officers were dispatched to a domestic assault in progress at the Ketchikan Apartments. Upon arriving officers heard a female screaming for help. Officers interviewed a female who stated she had been assaulted by MEDICINE W.G. CHANEY, 31 years of age, of Ketchikan, Alaska. Mr. Chaney was arrested for Assault in the Fourth Degree-Domestic Violence, Violation of Conditions of Release and Harassment in the First Degree. He was transported to the Ketchikan Correctional Center where he was held with no bail.

On 6/11/12 at approximately 2006 hours, officers responded to the 600 block of Dock Street for a report of two males trespassing. Officer made contact with MARK A. HILL, 51 years of age, and GARY L. HAMILTON, 55 years of age both of Ketchikan, Alaska. Mr. Hill was arrested for Criminal Trespass in the Second Degree and Violation of Conditions of Release. Both men were transported to the Ketchikan Correctional Center. Mr. Hill was held on \$500.00 bail. Mr. Hamilton was arrested for Criminal Trespass and set to be released on His own Recognizance.

On 6/12/12 at approximately 1352 hours, officers arrested JEFFREY A. CLARK, 48 years of age, of Ketchikan, Alaska, on an outstanding warrant. He was transported to the Ketchikan Correctional Center and held on \$5,000.00 bail.

On 6/12/12 at approximately 1541 hours, officers arrested MICHAEL T. DUPREE, 23 years of age, of Ketchikan, Alaska, on an outstanding warrant. He was transported to the Ketchikan Correctional Center and held on \$10,000.00 bail.

Officers followed vehicle and made contact with MICHAEL J. MILNE, 20 years of age, of Ketchikan, Alaska. He was arrested for No Valid Operator's License.

On 6/14/12 at approximately 1549 hours, officers arrested JASON E. RASMUSSEN, 40 years of age, of Ketchikan, Alaska on an outstanding warrant. He was transported to the Ketchikan Correctional Center where he was held with no bail.

On 6/17/12 at approximately 0157 hours, while stopped in front of the First City Saloon officers observed a male staggering down that sidewalk having trouble keeping his balance and enter a 2011 Chevrolet Sedan through the driver's door and turn the vehicle on. Officers made contact with MICHAEL A. ABSHER, 50 years of age, of Port Angeles, Washington. Mr. Absher was arrested for Driving Under the Influence and Refusal to Submit to a Chemical Test. He was transported to the Ketchikan Correctional Center where he was set to be released on his own recognizance.

On 6/17/12 at approximately 1636 hours, Officers were dispatched to Timeline Court due to a report of an unknown male asleep on a couch. Officers made contact with the sleeping man, BRUCE B. REEVES, 45 years of age, of Ketchikan, Alaska was intoxicated. He was arrested for Violation of Conditions of Release, transported to the Ketchikan Correctional Center and held on \$500.00 bail.

On 6/17/12 at approximately 1707 hours, officers were dispatched to Woodside Apartments for a report of possible domestic violence assault. Officers interviewed a female who stated DAYLON D. KROUT, 24 years of age, of Ketchikan, Alaska, kicked in the door to her apartment, entered without her permission, pulled the phone cord out to prevent her from calling the police, while outside he grabbed and held her until she yelled at the people in the parking lot. Officer made contact with and arrested Mr. Krout for Criminal Mischief in the Fourth Degree, Criminal Trespass in the First Degree, Interfering with a Report of a Crime Involving Domestic Violence and Assault in the Fourth Degree – Domestic Violence. He was transported to the Ketchikan Correctional Center and held without bail.

On 6/18/12 at approximately 0447 hours officers were dispatched to the 300 block of Edmond Street due to a report of a domestic disturbance in progress. Officers interviewed a female who stated JUAN J. RANGEL, JR., 38 years of age, of Ketchikan, Alaska, grabbed her by the shoulder as she was trying to leave and pulled her down to the ground causing her to land on top of a child's bicycle, she attempted to get up and he pushed her back down causing her fear of being injured and he grabbed and broke her cell phone while she was on the phone with the police. Officers contacted Mr. Rangel and arrested him for Assault in the Fourth Degree – Domestic Violence and Interfering with a Report of a Crime Involving Domestic Violence. He was transported to the Ketchikan Correctional Center and held without bail.

On 6/18/12 at approximately 0651 hours, Officers were dispatched to the State Office Building due to a report on a male sleeping under a vehicle. Officers observed JAMES M. HOWE, 40 years of age, of Ketchikan, Alaska, urinating near the vehicle exit of the garage. Mr. Howe was arrested for Disorderly Conduct – Urinates in Public. He was

transported to the Ketchikan Correctional Center where he was set to be released on his own recognizance.

On 06/18/12 at approximately 1850 hours, officer responded to Second Avenue and Washington Street due to a report of a Protective Order Violation. Officer contacted a female who stated that DOMINIC MACNAMARA, 27 years of age, of Skagway, Alaska, walked within 500 feet of her residence and going by her place of employment but has not entered either location. Officers were unable to locate Mr. MacNamera. On 06-22-12, Mr. MacNamera turned himself into KPD lobby and was transported to the Ketchikan Correctional Center where he was held on no bail.

On 6/19/12 at approximately 1114 hours, officers arrested FRANK M. GUTHRIE, 42 years of age, of Ketchikan, Alaska, on an outstanding warrant. He was transported to the Ketchikan Correctional Center where he was held without bail.

On 6/19/12 at approximately 1306 hours, officers arrested JASON E. RASMUSSEN, 40 years of age, of Ketchikan, Alaska on two outstanding warrants. He was transported to the Ketchikan Correctional Center where he was held on \$6,500.00 bail.
