On 6/1/12 at approximately 0449 hours, officers received a report of a intoxicated male yelling and screaming obscenities and appears to have been beaten up on the corner of Mill and Main Street. Officers made contact with JASON D. NEUMEISTER, 37 years of age, of Ketchikan, Alaska. Upon investigation he was arrested for Disorderly Conduct-Loud Noise. He was transported to the Ketchikan Correctional Center where he was set to be Released On His On Recognizance.

On 6/2/12 at approximately 1121 hours, officers responded to the Plaza Mall due to a report of intoxicated female who would not leave the area.
