On 5/21/12 at approximately 0106 hours, officers conducted a traffic stop in the 3300 block of Tongass Avenue. JASON K. YOUNG, 34 years of age of Ketchikan, Alaska issued a Misdemeanor Citation for Driving While License Suspended in the State of Montana.

On 5/21/12 at approximately 1632 hours, officers responded to the 1300 block of Stedman Street due to a report of a motor vehicle collision and the female driver was fleeing the area on foot. Officers made contact with DANIELLE LOGAN, 30 years of age of Ketchikan, Alaska, she was found to show signs of intoxication. Ms. Logan was transported to the Ketchikan Correctional Center where she was booked for Driving Under the Influence and Driving While License Revoked. She was held on \$1,500.00 bail.
