On 4/30/12 at about 2236 hours officers arrested SHARON SAMSON, 20 years of age, of Ketchikan, at the Police department for an outstanding warrant. She was transported to the Ketchikan Correctional Center where she was held on \$500.00 bail.

On 5/01/12 at about 0054 hours officers responded to the Asylum Bar due to a report of KAMI D. RILEY, 37 years of age, of Ketchikan Alaska, was inside causing a disturbance and refusing to leave. She was found to show signs of being highly intoxicated and was warned to not enter any more bars for the night. On 5/18/12 at about 2302 hours officers conducted a traffic stop on a black 2004 Mercury, in the 1200 block of Tongass for a traffic violation. Upon investigation officers arrested JOSEPH BUENDIA, 21 years of age, of Ketchikan Alaska, for Operating a Motor Vehicle While Under the Influence. He was transported to the Ketchikan Correctional Center where he was set to be released on his own recognizance.

On 5/20/12 at about 0538 hours officers arrested DENISE TEVELDE, 45 years of age, of Ketchikan Alaska, on an outstanding warrant. She was transported to the Ketchikan Correctional Center where she was held on \$5000.00 bail.
