On 3/30/12 at about 0702 hours officers were dispatched to Maple Ct. on a report of a male trespassing in a car. Officers responded and arrested CHRISTIAN B. PEREZ, 26 years of age of Ketchikan Alaska, for Criminal Trespass in the Second Degree. He was transported to the Ketchikan Correctional Center where he was set to be released on his own recognizance.

On 3/30/12 at about 1334 hours officers were dispatched to the Plaza Mall on a report of an intoxicated male causing a disturbance and refusing to leave. Upon arriving officers contacted CHRISTOPHER R. COOPER, 27 years of age of Ketchikan Alaska, who was arrested for Criminal Trespass in the Second Degree. He was transported to the Ketchikan Correctional Center where he was set to be released on his own recognizance.

During the stop the officer smelled an overwhelming odor of marijuana coming from the car and asked the occupants to hand it over. Upon investigation Mr. Secrest was arrested for Assault in the Fourth Degree - Domestic Violence. He was transported to the Ketchikan Correctional Center where he was held without bail.

On 4/08/12 at about 2306 hours officers were dispatched to the area of Seventh Avenue on a report of a possible intoxicated driver in a white mini-van. Upon arriving officers conducted a traffic stop and identified MARY SCHMIDT, 53 years of age of Ketchikan Alaska, as the driver. Ms. Schmidt showed signs of intoxication. Ms. Schmidt was arrested for Driving Under the Influence. She was further charged with Refusal to Submit to Chemical Test. She was transported to the Ketchikan Correctional Center where she was set to be released on her own recognizance.

On 4/09/12 at about 0806 hours officers were dispatched to Buren Road on a report that a neighbor could hear a male and female screaming. Upon arriving officers contacted CHAD T. SECREST, 30 years of age of Ketchikan Alaska. Mr. Secrest gave officers a false name upon contact later saying he did not want to give his real name as he was under court order to not have any contact with the female. He was arrested for False Information to a Police Officer and Violation of Conditions of Release. He was transported to the Ketchikan Correctional Center where he was held on \$500.00 bail.

On 4/09/12 at about 0920 hours officers responded to the Ketchikan High School on a report a student had made threatening comments and left the area. Upon investigation officers arrested FERRIS HAYWARD, 18 years of age of Ketchikan Alaska, for Terroristic Threatening in the Second Degree. He was transported to the Ketchikan Correctional Center where he was booked and held without bail.

On 4/09/12 at about 0954 hours officers contacted STEVEN LAWRENCE, 32 years of age of Ketchikan Alaska in the 3300 block of Tongass. Mr. Lawrence was found to be in violation of a court order. He was arrested for Violation of Conditions of Release and transported to Ketchikan Correctional Center where he was booked and held on \$500.00 bail.
