On 3/23/2012 at about 1845 hours, officers conducted a traffic stop in the 5800 block of Tongass for a minor driving violation. During the contact officers contacted the passenger in the car, STEFAN MEDFORD, 19 years of age of Ketchikan Alaska, who admitted to having marijuana in his possession. Officers applied K9 Booker to the vehicle and he indicated to the odor of drugs in Mr. Medford's duffle bag. Mr. Medford was issued a misdemeanor citation for Misconduct Involving a Controlled Substance in the Sixth Degree.

On 3/23/2012 at about 2147 hours, officers contacted ERIC JENSEN, 36 years of age of Ketchikan Alaska. Mr. Jensen showed signs of being very intoxicated and was found to be on conditions of release which prohibited him from consuming alcohol. Mr. Jensen was arrested for Violation of Conditions of Release. He was transported to the Ketchikan Correctional Center where he was held on \$500.00 bail.

On 3/24/12 at about 1535 hours, officers were dispatched to the Residential Youth Center on a report of an assault against a staff member. Upon investigation officers arrested a 12 year old male for Assault in the Fourth Degree.

On 3/27/12 at about 1041 hours officers were dispatched to the Residential Youth Center on a report of a theft. Upon investigation officers arrested a 17 year old male for Theft in the Fourth Degree and Criminal Trespass in the Second Degree for the theft of \$16.00 and a cell phone.

On 3/28/12 at about 1138 hours officers arrested NEIL HARTIES, 42 years of age of Ketchikan Alaska, on two outstanding warrants. He was transported to the Ketchikan Correctional Center where he was held without bail.

On 3/29/12 at about 1150 hours officers arrested JORDAN VONDA, 20 years of age of Ketchikan Alaska, on an outstanding warrant. He was transported to the Ketchikan Correctional Center where he was held on \$2500.00 bail.

On 3/29/12 at about 2309 hours, officers issued JORDAN WILLIAMS, 22 years of age of Ketchikan Alaska, a misdemeanor citation for Driving While License Revoked.

On 3/30/12 at about 0116 hours, officers were dispatched to Tongass Towers on a report that CURTIS WALLIN, 38 years of age of Ketchikan Alaska, was intoxicated and in violation of conditions of release. Upon arriving officers contacted Mr. Wallin who did show signs of intoxication and was also found to be on conditions. He was arrested for Violation of Conditions of Release and transported to the Ketchikan Correctional Center where he was held on \$500.00 bail.
