On 3/01/12 at approximately 0253 hours, officers issued JAMES THOMAS EDWARD INGLE, 23 years of age of Ketchikan Alaska, a misdemeanor citation for Driving While License Revoke.

On 3/03/12 at approximately 1018 hours, officers arrested STEPHAN HASELTINE, 27 years of age of Ketchikan Alaska, for an outstanding arrest warrant. The warrant stemmed from a theft case from Wal-Mart on 02/29/12 where over \$600.00 in merchandise was taken. Mr. Haseltine was transported to the Ketchikan Correctional Center where he was booked and held on \$2500.00 bail. In an unrelated case Mr. Haseltine arrested on warrants for four counts of Theft in the Second Degree(C Felony), two counts of Burglary in the Second Degree(C Felony) and two counts of Criminal Mischief in the Third Degree(C Felony).

On 3/03/12 at approximately 2127 hours officers were dispatched to Marine View to take a report of a domestic dispute. Upon investigation officers arrested LEVIE PABILONA, 37 years of age of Ketchikan Alaska, for Assault in the Fourth Degree Domestic Violence. He was transported to the Ketchikan Correctional Center where he was held without bail.

On 3/03/12 at approximately 2346 hours, officers responded to Hawkins Avenue on a report of a domestic disturbance. Upon arriving officers contacted MATTHEW SMITH, 28 years of age of Ketchikan Alaska. During the investigation Mr. Smith became hostile and aggressive towards officers, accusing them of stealing his marijuana pipe. He was arrested for Disorderly Conduct and transported to the Ketchikan Correctional Center where he was held on \$250.00 bail.

On 3/04/12 at approximately 0309 hours, officers responded to Water Street regarding a male refusing to leave a residence. Upon arriving officers contacted TREVOR KEARNEY, 42 years of age of Ketchikan Alaska. Mr. Kearney was asked to leave by both the home owner and officers, but refused to do so. He was arrested for Criminal Trespass in the Second Degree and transported to the Ketchikan Correctional Center where he was set to be released on his own recognizances.

On 3/04/12 at approximately 1105 hours Officers were requested to the end of East Street in the parking lot for a report of people smashing bottles of alcohol on the rocks. Officers contacted JAMES M. HOWE, 39 years of age of Ketchikan Alaska, who was found to have an open container of alcohol. He was arrested for Disorderly Conduct and transported to the Ketchikan Correctional Center where he was set to be released on his own recognizances.

On 3/04/12 at approximately 1310 hours, officers contacted a female in the lobby of the Department who wanted to report a domestic assault. The female was found to have injuries including bit marks on her face. Officers were able to contact ERIC W. CONNOR, 21 years of age of Ketchikan Alaska, who was arrested for Assault in the Fourth Degree, and Violation of Conditions of Release. He was transported to the Ketchikan Correctional Center where he was held without bail.

On 3/05/12 at about 0945 hours, officers arrested REBECCA L. EMRA, 36 years of age of Ketchikan Alaska, on an outstanding warrant. She was transported to the Ketchikan Correctional Center where she was held without bail.
