On 02/25/12 at approximately 1208 hours, while on vehicle patrol officers saw a male in the 200 block of Stedman Street blocking traffic. Officers contacted SCOTT MORGAN, 49 years of age of Ketchikan Alaska, who showed signs of being highly intoxicated. He was walking in the lane of traffic causing cars to back up and go into oncoming traffic to get by. Mr. Morgan refused to leave the road way and was arrested for Obstruction of a Highway. He transported to the Ketchikan Correctional Center where he was set to be released on his own recognizance.

On 2/25/12 at approximately 0157 hours, officers responded to 1st City Saloon regarding an assault. Upon arriving officers contacted TEEKA EDENSHAW, 21 years of age of Ketchikan Alaska. After investigation Ms. Edenshaw was arrested for Assault in the Fourth Degree. She was transported to the Ketchikan Correction Center where she was booked. While at the Correctional Center Ms. Edenshaw was found to be in possession of a controlled substance. She was further booked on Misconduct Involving a Controlled Substance in the Fifth Degree. She was held without bail.

On 02/25/12 at approximately 2230 hours, officers issued a misdemeanor citation to GAVIN R. HUDSON, 31 years of age of Shoreline Washington, for Driving While License Revoked.

On 02/26/12 at approximately 1556 hours, officers responded to the area of Carlanna Lake Road and Denali Avenue for a report of a male walking down the street with a bloody hand. Upon arriving officers contacted TRENT S. CUNNINGHAM, 19 years of age of Ketchikan Alaska. Mr. Cunningham showed signs of intoxication and became aggressive towards officers. At one point Mr. Cunningham started pushing officers. He was arrested for Disorderly Conduct. He was transported to the Ketchikan Correction Center where he was issued a citation for Consumption by A Person Under 21. He was booked and set to be released on his own recognizance.

On 02/26/12 at approximately 1742 hours, officers responded to the Narrows Inn on a report of a male possible violating a protective order. Upon arriving officers contacted NICHOLAS R. HISLE, 22 years of age of Ketchikan Alaska. Mr. Hisle was found to be with a female which was a violation. He was arrested for Unlawful Contact in the First Degree and Violation of Conditions of Release. He was transported to the Ketchikan Correctional Center where he was held without bail.

On 02/27/12 at approximately 1126 hours, officers arrested CALEB J. GORSLINE, 27 years of age of Ketchikan Alaska, on an outstanding warrant. He was also charged with Failing to Register as a Sex Offender in the Second Degree. He was transported to the Ketchikan Correction Center where he was booked and held on \$10,000.00 bail.

On 02/27/12 at approximately 1640 hours, officers responded to Wal-Mart due to a report of a shoplifter in custody. Upon arriving officers contacted GREGORIO J. MAKUA, 20 years of age of Ketchikan Alaska. Mr. Makua was found to have taken two boxes of .22 caliber Remington shells, total value \$44.46. He also had a warrant out for his arrest. He was arrested for Theft in the Fourth Degree and for his warrant. He was transported to the Ketchikan Correctional Center where he was held on \$25.00 bail for his warrant.
