On 02/15/12 at approximately 0059 hours, officers found a red and black Ford truck on Fairview Avenue with the back end stuck on top of a fire hydrant. Officers contacted FLOYD M. KERVIN, 51 years of age of Ketchikan Alaska, as the driver of the truck. Upon investigation Mr. Kervin was arrested for Driving Under the Influence. He was transported to the Ketchikan Correction Center where he was held on \$1500.00 bail. Mr. Kervin has two prior convictions for Driving Under the Influence in Texas.

On 2/16/12 at approximately 1411 hours, officers arrested STEVEN STAKER, 37 years of age of Ketchikan Alaska, on an outstanding warrant. He was transported to the Ketchikan Correctional Center where he was held on \$250.00 bail.

On 2/16/12 at approximately 1518 hours, officers arrested JORDAN VONDA, 20 years of age of Ketchikan Alaska, on an outstanding warrant. He was transported to the Ketchikan Correctional Center where he was held on \$1,500 bail.

On 2/16/12 at approximately 1939 hours, officers issued RACHEL DEMMERT, 32 years of age of Ketchikan Alaska, a misdemeanor citation for Driving While License Revoked.

On 2/17/12 at approximately 1330 hours, officers arrested SAMANTHA J GARTON, 23 years of age of Ketchikan Alaska, on three outstanding warrants. She was transported to the Ketchikan Correctional Center and held on \$300.00 bail.

On 2/18/12 at approximately 2000 hours, officers were dispatched to the Totem Bar due to a report of a female who had been stealing drinks and was refusing to leave the bar. Upon arriving officers contacted KAMI RILEY, 37 years of age of Ketchikan Alaska. Ms. Riley was escorted out of the bar and due to her high level of intoxication she was not allowed to enter any more licensed premises for the remainder of the night. A short time later officers contacted Ms. Riley inside the Artic Bar. Ms. Riley was arrested for Drunken Person's on a Licensed Premises. She was transported to the Ketchikan Correction Center where she was set to be released on her own recognizance.

On 2/18/12 at approximately 2040 hours, officers were dispatched to the Totem Bar on the report that a male had assaulted the bartender. Upon arriving officers contacted TOMMY SAM, 74 years of age of Sitka Alaska. During the investigation Mr. Sam became hostile with officers and was arrested for Disorderly Conduct - Violent and Tumultuous. He was transported to the Ketchikan Correction Center where she was set to be released on her own recognizance.

On 2/18/12 at approximately 2319 hours, officers contacted TONI MEREDITH, 35 years of age of Ketchikan Alaska, for a possible probation violation. Upon investigation Ms. Meredith was issued a misdemeanor citation for Violating Conditions of Release.

On 2/19/12 at approximately 0336 hours, officers, contacted a green Chevrolet Suburban parked on South Stedman. Upon investigating officers arrested ERIC TROUT, 36 years of age of Ketchikan Alaska, for Driving Under the Influence. He was transported to the Ketchikan Correctional Center where he was set to be released on his own recognizance.
