On 2/6/12 at approximately 1917 hours, officers responded to a report of three juveniles trespassing in a vehicle in the parking lot across from the Cedars Lodge. Two of the juveniles had fled the area and one was being held by the vehicle owner. Upon investigation officers were able to identify all three juveniles. All three were charged with Criminal Trespass in the Second Degree and were released to their parents.

On 2/7/12 at approximately 0049 hours, officers were dispatched to 832 Buren for a report of a male refusing to pay his cab fare. Upon arriving officers contacted SYLVESTER PEELE, 42 years of age of Ketchikan, Alaska. Mr. Peele was asked to pay his outstanding cab fare of \$20.30. Mr. Peele began yelling obscenities and demanded he be arrested. He was placed under arrested for Fourth Degree Theft and transported to the Ketchikan Correctional Center. He was set to be released on his own recognizance.

On 2/7/12 at approximately 1348 hours, officers responded to Arnold Avenue for a report of a possible domestic assault in progress. Upon arriving officers contacted NICHOLAS R. HISLE, 22 years of age of Ketchikan, Alaska. After investigating the complaint Mr. Hisle was arrested for Assault in the Fourth Degree – Domestic Violence and Violation of Conditions of Release. He was transported to the Ketchikan Correction Center. He was held without bail.

On 2/7/12 at approximately 1938 hours, officers were dispatched to First Avenue due to a 911 hang-up from that address. Upon investigation officers arrested ARTHUR R. FELARCA, 53 years of age of Ketchikan, Alaska, for Assault in the Fourth Degree – Domestic Violence. He was transported to the Ketchikan Correction Center where he was held without bail.

On 2/8/12 at approximately 1435 hours, officers were dispatched to a Tongass address, due to a report that MANDY E. PETERS, 29 years of age, was in violation of her conditions of release. Upon investigation Ms. Peters was arrested for Violation of Conditions of Release and a Probation Violation. She was transported to the Ketchikan Correction Center. She was held on \$7,000.00, bail.

On 2/11/12 at approximately 1411 hours, officers issued a Misdemeanor citation to GARY L. MYERS, 54 years of age of Ketchikan, Alaska, for Driving While License Suspended.

On 02/11/12 at approximately 1915 hours, officers were dispatched to Cedar Street for a report of KURT ROELFS, 40 years of age of Ketchikan, Alaska, for violating a protective order. Upon investigation Mr. Roelfs was arrested for Violating a Protective Order and Assault in the Second Degree - Domestic Violence. He was transported to the Ketchikan Correction Center. He was held with no bail.

Upon arriving officers took a report of a domestic assault that had occurred with the male having left the residence. At about 0600 hours the male, RYAN GOTELLI, 25 years of age, called and requested to talk to an officer. After investigating Mr. Gotelli was arrested for Assault in the Second Degree - Domestic Violence. He was transported to the Ketchikan Correction Center. He was held without bail.

On 2/12/12 at approximately 1545 hours, officers issued a Misdemeanor citation to JONATHAN W. WILSON, 23 years of age of Ketchikan, Alaska, for Driving While License Revoked.

On 2/12/12 at approximately 1623 hours, officers contacted RUBY A. HAYWARD, 31 years of age of Ketchikan, Alaska, to serve her a protective order. Officers learned she was out of compliance with her sex offender registration. She was arrested for Failing to Register as a Sex Offender in the First Degree. She was transported to the Ketchikan Correction Center. She was held without bail.

On 2/12/12 at approximately 1648 hours, officers responded to the Sourdough Bar for a report of a male that was assaulted. Upon arriving officers contacted STEVEN L. STAKER, 37 years of age of Ketchikan, Alaska. During the investigation Mr. Staker became aggressive towards another male and was warned to stop. He was arrested for Disorderly Conduct. He was transported to the Ketchikan Correctional Center. He was set to be released on his own recognizance.

On 2/13/12 at approximately 1420 hours, officers arrested ASHELY GRAFF, 20 years of age of Ketchikan, Alaska, on an outstanding warrant. She was transported to the Ketchikan Correctional Center. She was held on \$2500.00 bail.

On 2/14/12 at approximately 0330 hours, officers received a dispatched report of a domestic assault occurring at the Cape Fox Lodge. Upon arrival officers contacted JUAN RANGEL, 38 years of age of Ketchikan, Alaska. Mr. Rangel was arrested for Assault in the Fourth Degree. He was transported to the Ketchikan Correction Center. He was held without bail.
