On 2-1-12 at approximately 1157 hours officers received a dispatched report of a juvenile male being held at Ketchikan High School who had just assaulted another class mate. Upon investigation a 17 year old male was arrested for Assault in the Fourth Degree. He was later released to his parent.

On 2-1-12 at approximately 2316 hours officers were dispatched to the Totem Bar due to a male who was refusing to leave when directed by the bartender. Upon arriving officers contacted JEFFREY SKULTKA, 26 years of age of Ketchikan Alaska. Officers had contacted Mr. Skultka a short time prior and due to his high level of intoxication had warned him he was not to enter any more licensed premises for the night. He was arrested for Drunken Person on a Licensed Premise and transported to the Ketchikan Correctional Center where he was set to be released on his own recognizance.

On 2-2-12 at approximately 1921 hours officers arrested DOUG VILL, 52 years of age of Ketchikan Alaska, on an outstanding warrant.

On 2-2-12 at approximately 1953 hours officers arrested COREY THOMPSON, 22 years of age of Ketchikan Alaska, on an outstanding warrant.

On 2-3-12 at approximately 2000 hours officers arrested NICHOLAS KRISTOVICH, 29 years of age of Ketchikan Alaska, on an outstanding warrant.

On 2-4-12 at approximately 1251 hours officers arrested VIRGINIA DYSON, 31 years of age of Ketchikan Alaska, on two outstanding warrants.

On 2-5-12 at approximately 1233 hours officers arrested MICHAEL BAHAM, 26 years of age of Ketchikan Alaska, on an outstanding warrant.

On 2-5-12 at approximately 1543 hours officers contacted DOUG VILL, 52 years of age of Ketchikan Alaska. Mr. Vill showed signs of intoxication and was found to be on conditions of release which stated he was not to consume alcohol. Mr. Vill was arrested for Violation of Conditions of Release. He was transported to the Ketchikan Correctional Center where he was held on \$500.00 bail.

On 2-6-12 at approximately 1252 hours officers arrested CHRISTOPHER MOWERS, 40 years of age of Ketchikan Alaska, on an outstanding warrant.

On 2-6-12 at approximately 1335 hours officers arrested ALLEN BIRD, 41 years of age of Ketchikan Alaska, on an outstanding warrant.
