On 1-12-2012 at about 2239 hours, officers responded to Timberline Court regarding BRUCE REEVES, 45 years of age of Andre, violating a protective order. Upon investigation Mr. Reeves was arrested for Violation of a Protective Order and Violation of Condition of Release. He was transported to the Ketchikan Correctional Center where he was held without bail.

On 1-13-2012 ANDRE M. LECORNU, 34 years of age of Ketchikan Alaska, was found to be in violation of conditions of release and had two outstanding warrants for his arrest. He was transported to the Ketchikan Correctional Center where he was booked and held on without bail.

Upon arriving officers contacted CLYDE ORCUTT, 42 years of age of Ketchikan Alaska, who was found to have an open container of alcohol and showed signs of intoxication. He was arrested for Disorderly Conduct and transported to the Ketchikan Correctional Center where he was booked and set to be released on his own recognizance.
