On 12/2/2011 at approximately 2032 hours, officers responded to a driving complaint near Jefferson St. and 5th Ave involving a white Ford pickup, which was reported to have driven over the curb on Jefferson, made a wide turn, nearly striking a sign post and fence. It was reported the vehicle was parked in front of a residence in the area with the male driver still inside. Upon investigation officers arrested DANIEL R. PALMER, 46 years of age of Washington, for Driving Under the Influence and Driving While License Revoked. He was transported to the Ketchikan Correctional Center where he was held on \$1500.00 bail.

On 12/2/2011 at approximately 2010 hours, MAURICE BOOTH, 21 years of age of Ketchikan Alaska, was arrested on an outstanding warrant. He was transported to the Ketchikan Correctional Center where he was booked and held without bail.

On 12/3/2011 at approximately 0124 hours officers contacted a female waiting in the lobby who wanted to report an assault. After speaking to the female, officers contacted CHRISTOPHER EIDE, 28 years of age of Ketchikan Alaska. Mr. Eide was arrested for Assault in the Third Degree Domestic Violence. He was transported to the Ketchikan Correctional Center where he was held without bail.

On 12/3/2011 at approximately 0730 hours, I responded to Bryant Street due to a report of a single vehicle motor vehicle collision with no injuries, the vehicle was reported to be on a resident's front lawn. Upon investigation officers issued KATHRYN MARSH, 81 years of age of Ketchikan Alaska, a citation for No Valid Operator's License.

On 12/4/11 at approximately 1141 hours, officers responded to First Avenue on a report of a theft. Upon investigation a 14 year of female was arrested for Theft in the Third Degree.

On 12/4/11 at approximately 1945 hours, officers were dispatched to Stedman Street for a complaint that TERRI ENSIGN, 43 years of age of Ketchikan Alaska, was violating her conditions of release by being intoxicated. Upon investigation Ms. Ensign was arrested for Violation of Conditions of Release. She was transported to the Ketchikan Correctional Center. During the booking process officers located a controlled substance. Ms. Ensign was also charged with Misconduct Involving a Controlled Substance in the Sixth Degree. She was held on \$500.00 bail.

On 12/4/11 at approximately 2047 hours, officers contacted GREGORY J. STEELE, 43 years of age of Sitka Alaska, in the 100 block of Stedman Street. Upon investigation it was learned Mr. Steele had been involved in an altercation with several other males. During the contact Mr. Steele became violent and assaulted one of the officers. He was arrested for Assault in the Fourth Degree, on a Peace Officer. He was transported to the Ketchikan Correctional Center where he was booked and held on \$1000.00 bail.
