FRIDAY 07-22-11

At approximately 2:00 p.m. JAMES M. HOWE, 39 years of age, of Ketchikan, Alaska was arrested and charged with Disorderly Conduct-Open Container. Mr. Howe was booked and held at the Ketchikan Correctional Center.

SATURDAY 07-23-11

At approximately 12:30 a.m. CALE E. MOODY, 23 years of age, address unknown was arrested and charged with Driving Under the Influence, and Refusal to Submit to A Chemical Test. Officers contacted Moody on Stedman Street after observing his vehicle drive erratically. Upon contact officers could detect an odor of intoxicants on his person, and he was asked to perform field sobriety tests and to provide a breath sample.
