WEDNESDAY 03-16-11

At approximately 8:00 p.m. SHERRI L. YELTATZIE, 41 years of age, of Ketchikan, Alaska was arrested and charged with Violation of Conditions of Release. Ms. Yeltatzie was booked and held on \$100 bail at the Ketchikan Correctional Center.
