Mayor Williams called the public hearing on Resolution No. 13-2528 to order at 7:02 p.m. and requested public testimony.

As there was no testimony, Mayor Williams declared the public hearing closed at 7:02 p.m.



COMMUNICATIONS

Mayor Williams said there were a couple of things laid on the table, including: a report from Acting Electric Division Manager Donato regarding supplemental diesel generation; and early office closures on Christmas Eve and New Year's Eve.

PERSONS TO BE HEARD

Kathleen Light, Executive Director of Ketchikan Area Arts and Humanities Council, reported on the activities of the Arts Council during October and November. She

addressed several exhibits, the Winter Arts Faire, and the Winter Art Walk. She commented on a community meeting that was held and noted that concern came up regarding scheduling of events. She explained they have been working the past few weeks with the city clerk's office to use the calendar that is on the City's website, to coordinate events in the community. She said it has been working so far, and they will meet again in February to determine if this is the way to go.

Ms. Light also reported on arts education, specifically working with the schools to promote arts education. She stated today they learned that Ketchikan has been selected to host a basic arts institute this summer in partnership with the Alaska Arts Education Consortium. She explained the basic arts institute is a two-week intensive summer opportunity for educators to learn how to use the arts to motivate and increase student learning. She said these are tools that educators will be able to use for our students immediately. She concluded by encouraging the Council to keep the community agency funding at the same level as last year.

Thane Peterson spoke regarding the proposed building code ordinance, stating he would like to see that if the local code hasn't adopted an exception to a section of the International Building Code, any sections the State has excepted will automatically apply.

Building Official Dearden spoke to the process that was taken to arrive at the ordinance, and Mr. Peterson said he would like to see where Ketchikan has not codified something into law for a pertinent issue, that the City will refer back to the State of Alaska amendments instead of the International Building Code.

Public Works Director Allen said that was a very broad question, noting the code is based on Alaska statute and further customized for Ketchikan. He continued lacking any definitive specifics about what is being requested, he stated staff has the ability to address the variations that come through the individual permits. He reminded the City also has the appeals board, which is not just public employees. Manager Amylon summarized it appears the manner in which we are doing it allows the discretion at the local level.

MAYOR AND COUNCIL COMMENTS

Councilmember Harris apologized for missing the last Council meeting, and he encouraged all people to get out there to thank a vet. He said we wouldn't be here if we didn't have the vets who took care of us to get us here. He also mentioned a couple weeks ago the Council showed hands to stick with the 2013 budget, noting he wasn't one of the ones who raised his hand. Councilmember Sivertsen also thanked Mr. Bergeron for his service, and he said it was a real prestigious award for the clerk that was awarded by peers. He said it was nice to be there to see her accept the award, and he offered his congratulations.

Councilmember Zenge echoed everyone's comments, thanking the clerk's office for the arrangements made for the NEO training. She said it was very long training, but she really enjoyed the experience in Anchorage, noting it was very, very cold.

Mayor Williams also thanked Clerk Suiter, and said he hoped things go well for Mr. Bergeron in the future. He expressed happiness on the building code, stating it didn't go as well in prior years. He reported on Monday he met with Mike Chenalt, speaker of the house, along with Mr. Acteson and Mayor Kiffer, to push Swan Lake and other projects. He said he has gotten all kinds of input on the rain gauge, stating there are people who

want to make it where it is a real rain gauge and others who don't want to spend the money. He went on to say this has caused a lot of talk and he was enjoying listening to people. He stated there are a lot of locals who would like to have some input, and he told them as it moves forward they would get a chance to throw their ideas out. He reported he cracked the budget, but hasn't gotten very far. He wished everyone a Happy Thanksgiving.
