EXECUTIVE SESSIONS

Request for Executive Session – Little Susitna Construction Company vs. City of Ketchikan, Case No. IKE-12-13 Civil

Moved by Sivertsen, seconded by Olsen the City Council declare that it is in the best interest of the City to go into executive session in accordance with KMC 2.04.025(a)(1) and AS 44.62.310(c)(1) and (3) to discuss Little Susitna Construction Company's complaint Case No. 1KE-12-13 Civil in the Superior Court for the State of Alaska at Ketchikan, which includes the need to discuss subjects the knowledge of which could have an adverse impact upon the finances of the City and to discuss potential litigation strategies with legal counsel within the attorney-client privilege.

to \$1,241,094 from Appropriated Reserves of the Public Works Sales Tax Fund to the 2012 Ketchikan General Hospital Surgery Suite Interim Repairs Capital Account
