On 11/6/2015 at approximately 1126 hours, Officers contacted Marika Garner, age 21 in the lobby of the police department. Ms. Garner was found to have an outstanding warrant. She was transported to the State Jail and held without bail.

On 11/6/2015 at approximately 2027 hours, Officers responded to the hospital to a report of a male refusing to leave. Officers contacted Stephen Elie, age 52, who refused to leave after being asked by hospital security and officers. Mr. Elie was charged with Criminal Trespass. He was transported to State Jail and released on his own recognizance.
