On 9/9/2015 at approximately 1337 hours, Officers responded to a west end store to a report of a shoplifter in custody. Officers contacted Cherish Banks, age 33, who left the store with merchandise. Ms. Banks was cited for Theft in the Fourth Degree.

On 9/11/2015 at approximately 1108 hours, Officers responded to a west end grocery store to a report of a shoplifter in custody. Offices contacted Theodore Rado, age 46, who consumed merchandise from the store. Mr. Rado was cited for Theft in the Fourth Degree.

He was transported to the State Jail and held on \$2000.00 bail.

On 9/14/2015 at approximately 1902 hours, Officers contacted Bryon Melton, age 28, in the 1100 block of Copper Ridge Road. Mr. Melton was found to have an outstanding warrant from Palmer, AK. He was transported to the State Jail and held on \$5000.00 bail.
