As a Councilmember, I want to thank you for your correspondence with us and for working so effectively with our City Staff to address your understandable concerns on Wentworth Court. I can see you have an open and effective dialogue with Rebecca, so you are in excellent hands! As for the Council Meeting, I agree with you...it was entertaining. I do apologize about misunderstanding your gender and I'm sorry you had to sit through the chicken debacle!

As for Measure L, City Staff cannot promote it, as Rebecca explained. But I can! Measure L is CRITICAL to the future of Placerville as it will give us the funding to address our dire infrastructure needs as are apparent on Wentworth Court. I have a few suggestions:

- 1) Go to our website, www.FixPlacervilleRoads.com. It will answer all your questions and will give you a current list of your friends and neighbors who have endorsed Measure L. You may be shocked to know that over 75% of Placerville roads are in the Failed-At Risk category. 34% of our sewer system is in immediate need of repair. 25% of our water is leaking. Measure L will give us the funding to fix these critical problems.
- 2) I've attached an Endorsement/Fact Sheet. If you'd be willing to endorse the Measure, we'd love to put your name on the list!
- 3) Look for our Educational Segments on our local Foothill 7 TV station. They will be airing about 4 times a day in the near future and will help answer your questions. This airtime was generously donated by Ron Thompson of Thompson's Toyota as he saw the importance of Measure L to Placerville's future.

Thank you for looking into it and for working with our City Staff. Placerville is a wonderful place because of committed neighbors like you.
