12.4 Review and make recommendations for Solar Power locations City-Wide (Mr. Morris)

City Manager Morris summarized the recommendation based on the workshop held earlier as follows:

Net Metering sites:

- Water Reclamation Facility Only on the current site, Do not expand across road
- Corporation Yard including covers for equipment and materials as noted

 2.1 for a filled Parking Covers and Not Materials for City

3d floor of Parking Garage – Net Metering for City Hall, Town Hall and Old City Hall

- RESBCT Program: None
- Battery Storage: Consider for all sites including Police Department and Aquatic Center

It was moved by Councilmember Acuna to direct staff to precede working with the consultant to look at placing Solar Panels at the West Field, the City Hall 3rd Floor Parking Structure and the City's corporate yard. In addition, to look at placing battery storage generation systems at the Water Reclamation Facility, Police Department and City Aquatic Center. The motion was seconded by Councilmember Borelli and was unanimous.

12.1 Adopt a revision of the preferred material selection to the stamped and colored crosswalk to asphalt with Traffic Patterns XD as part of the Central Main Street Rehabilitation Project (CIP #414124)

Councilmember Thomas asked about the savings resulting from the change to asphalt from concrete on the crosswalks on Main Street. Ms. Reves reported that savings would go back to the respective funds they come from, for use on active CIP projects.
