Subject: Adopt a resolution approving the Update to the *City of Placerville Development Guide*.

Update *City of Placerville Development Guide*: The City initiated update of the City's Development Guide, including staff's recommended updates/changes is provided as Attachment A. Proposed changes utilize underline and strikeout formatting, with new text <u>underlined</u> and deleted text struck through.

The City's Final Draft was released to the public via links from the Development Services Department and City webpages and a post to the City's Facebook account on March 22, 2016. The Final Draft was distributed to Council Members on March 22, 2016

Background: The Development Guide was approved on August 25, 1992 by City Council Resolution 5549. The consulting firm, The HLA Group, was authorized in 1991 by the City Council to prepare a design / development guide for the City of Placerville. The adoption of design guidelines was identified as an implementation program within the City's General Plan (Section VII, Community Design, Implementation Programs 1 and 4).

The Development Guide serves as a tool to assist the public, the development community (developers, design professionals, engineers, architects, etc.), City staff, the Planning Commission and City Council in the planning and design of public and private development projects that will contribute to the City's historic context and sense of place. They also further goals and policies within the General Plan Community Design Section relative to community design.

On July 8, 2008, the City Council adopted Resolution No. 7626 that amended the Development Guide's Appendix A, Plant Lists, and it established a minimum threshold requirement of thirty-five percent (35%) of the total quantity of native trees and shrubs that must be included with landscape plan submittals subject to discretionary review (Site Plan Review, Planned Development project).

On September 14, 2010, the City Council adopted the Master Street Tree Plan – Tree Palette, adding it to the Appendix G of the City of Placerville Development Guide.

On October 30, 2012, the City Council, Planning Commission and Historical Advisory Committee conducted a special joint workshop to discuss City design guidelines. By consensus, there was agreement that the *City of Placerville Development Guide* (Development Guide) should be updated and made more user friendly; contain references to other relevant documents;

and include application procedures and flow charts of required information that apply to various project applications. At the conclusion of the workshop, City Council directed staff to integrate an update of the Development Guide into a Development Services Department work plan.

Work Plan: Several public workshops were conducted by the Planning Commission regarding Development Guide update contents. In addition, the City's Community Pride Committee and the former Historical Advisory Committee also reviewed and provided recommendations to staff on components of the Development Guide. These workshops and meeting agendas were made available to the public. The public was encouraged to attend and provide input.

Environmental Determination: The Development Guide Update project is exempt from environmental review per California Environmental Quality Act (CEQA) Guidelines under the General Rule (Section 15061 (b)(3)). The project involves updates and revisions to existing guidelines for the planning, design and processing of development activities within the City. It can be seen with certainty that the proposed amendments to the City of Placerville Development Guide will have no significant negative effect on the environment.

Implementation: Upon approval, the Placerville Development Guide would go into effect. Staff will make the Development Guide available to the public in print for purchase, and electronic

format with hyperlinks to relevant City codes and supplemental sources of information via the City's website.

Options:

- 1. Adopt a resolution approving the Update to the City of Placerville Development Guide. The resolution is provided as Attachment B.
- 2. Revise the Development Guide Update and approve the Update by resolution.
- 3. Do not adopt the resolution, direct staff to revise the Update accordingly, and then return to the City Council for approval.
- 4. Do not adopt the resolution.

Fiscal Impact: There is no direct fiscal impact to the City. The Development Guide Update will be available electronically and in hardcopy form. There will be no costs associated with the electronic form. Direct costs to create a hardcopy version for distribution will be recouped through the charge to duplicate the document.
