

**RESOLUTION NO. 7857**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLACERVILLE,  
ESTABLISHING PARKING FINES PURSUANT TO TITLE 9, CHAPTER 5,  
SECTION 3 (A) OF THE CITY'S MUNICIPAL CODE**

**WHEREAS**, City Municipal Code Section 9-5-3 provides that the City Council, by a Master Parking Fine Resolution, shall establish the fines for parking violations pursuant to Chapters 3, 4, and 5 of Title 9 of the City's Municipal Code; and

**WHEREAS**, it is the desire of the City Council to establish said parking fines; and

**WHEREAS**, the City currently collects \$8.00 in State surcharges; and

**WHEREAS**, Senate Bill 425 increased the court construction penalty by \$1.50 and Senate Bill 857 updated Government Code Section 76000.3 and added a \$3.00 surcharge to be deposited in the Trial Court Trust Fund for each Parking Violation; and

**WHEREAS**, the State Department of Motor Vehicles only collects fees in whole dollar amounts and rounds down when placing holds on citation recipient records; and

**WHEREAS**, it is the City's desire to adjust parking fines by the additional \$4.50 State surcharges plus an additional \$0.50 in order to avoid having to subsidize the cost of issuing parking citations.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Placerville hereby adopts the attached Master Parking Citation Fines Schedule (Attachment "A") pursuant to City Municipal Code Section 9-5-3 (A) for violations of Chapters 3, 4, and 5 of Title 9 of the Placerville Municipal Code, which fines shall be effective December 24, 2010.

The foregoing Resolution was moved for adoption at a regular meeting of the City Council of the City of Placerville held on November 23, 2010, by Councilmember Hagen who moved its adoption. The motion was seconded by Councilmember Machado. The motion was passed by the following vote:
