SUBJECT: GRANT OF STORM DRAIN EASEMENT AT QUARTZ MOUNTAIN

SUBDIVISION (APN 001-071-20)

RECOMMENDATION

That the Council adopts a Resolution as follows:

- 1. Accepting the grant of a Storm Drain Easement attached hereto and incorporated herein by reference, and authorizing the Mayor and City Clerk to execute same.
- 2. Authorizing the City Clerk to record the Offer of Street Dedication with the Office of the County Recorder, El Dorado County.

BACKGROUND

As a Condition of Approval for the Quartz Mountain Subdivision, (TPM 86-02), the property owner was required to provide an easement for drainage.

DISCUSSION

Staff conditioned the Developer to construct drainage improvements and to grant a Drainage Easement as necessary to provide the City those land rights required to operate and maintain this system. This council action will accept these easements giving the City the right to enter and maintain these facilities as required.

FISCAL ANALYSIS

No fiscal impacts are associated with the acceptance of this easement, however, additional fiscal impacts will accrue for maintenance of the drainage system by the City.
