4. NEW BUSINESS

5.1 Amendments to the City of Placerville Development Guide – Chapter XIII. Signage:

The Commission to consider text and graphic additions and amendments to the Development Guide's Chapter XIII, and then make a recommendation to City Council regarding the additions and amendments. Amendments are intended to help illustrate for the user of the Development Guide as to appropriate placement locations for sign types, to bolster existing guidelines relative to sign materials and sign illumination generally within Placerville, and within the City's historic commercial corridor along Main Street.

Staff's report was given by Director Rivas. Public comment was received from Kathi Lishman, and Mike Drobesh. Individual comments and suggestions were received from each Planning Commissioner. By general consent, the Commission directed staff to return to the Commission with revised modifications to include the following:
(1) Label each photo and referenced in the text if applicable; (2) Review Zoning

Ordinance and reference the Development Guide; and (3) Retain sentence shown as strikeout on Page III-3 B.(A)6.

5.2 Zoning Text Amendments: Front Yard Fencing, Walls and Use Restrictions - Zone Change (ZC) 10-02: The Planning Commission is requested to make recommendation regarding ZC 10-02 to City Council. The Placerville Development Services Department has initiated amendments to the Placerville Zoning Ordinance to address City Council community aesthetic concerns regarding the height and location of fences and walls, and use restrictions in front yards. These amendments involve Section 10-4-3: Yards. Environmental Review: Categorically exempt from environmental review pursuant to Section 15061(b)(3) of the California Environmental Quality Act (CEQA) Guidelines.

Director Rivas presented the staff report. Public comments were received from Mandi Winnicki, Will Morgan, Mike Drobes, Evelyn Veerkamp, and Kathi Lishman. Individual comments and suggestions were received from each Planning Commissioner. By general consent, the Commission continued the item and directed staff to return to the Commission in two weeks (June 20, 2017 regular meeting), and requested that staff bring back examples from other jurisdictions regarding the parking/storage of RVs.
