A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLACERVILLE APPROVING A CONSULTING SERVICES AGREEMENT WITH DRAKE HAGLAN AND ASSOCIATES IN AN AMOUNT NOT TO EXCEED \$1,225,727.43 FOR CONSTRUCTION MANAGEMENT SERVICES AND APPROVING AUTHORIZATION NO. 9 TO THE CONSULTANT SERVICES AGREEMENT WITH DOKKEN ENGINEERING IN AN AMOUNT NOT TO EXCEED \$192,878 FOR CONSTRUCTION SUPPORT ENGINEERING, APPROVING BUDGET APPROPRIATIONS TOTALING \$11,652,620, AND AUTHORIZING CITY STAFF TO RELEASE CONSTRUCTION CONTRACT DOCUMENTS FOR PUBLIC BIDDING FOR THE WESTERN PLACERVILLE INTERCHANGES PHASE 2 PROJECT (CIP #41828)

WHEREAS, on June 24, 2014, the City Council approved the Supplemental EIR and selection of Modified Alternative D as the preferred alternative for the Western Placerville Interchanges Project, Phase 2; and

WHEREAS, the design, utility coordination, and right-of-way phases of the project are complete and the project funding has been obligated and authorized through funding oversight with Caltrans to allow the project to proceed with construction related activities and contracts: and

WHEREAS, the City received the authorization to proceed for all construction related activities on October 12, 2017 from Caltrans Headquarters operating as the oversight agency for the project funding and is now ready to move the project forward into construction.

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of Placerville does hereby:

- Approve a Consulting Services Agreement with Drake Haglan and Associates in an amount not to exceed \$1,225,727.43 for construction management services for the Western Placerville Interchanges Phase 2 Project (CIP #41828) and authorizing the City Manager or his designee to execute the same; and
- 2. Approve Authorization No. 9 to the Consulting Services Agreement with Dokken Engineering in an amount not to exceed \$192,878 for Construction Support Engineering; and
- 3. Approve a \$470,000 budget appropriation in SHOPP Minor revenues for the said project; and
- 4. Approve a \$5,542,000 budget appropriation in STIP/RIP revenues for the said project; and
- 5. Approve a \$335,000 budget appropriation in State Transit Assistance (EDCTA) revenues for the said project; and
- 6. Approve a \$2,766,000 budget appropriation in CMAQ (partially EDCTA) revenues for the said project; and

- 7. Approve a \$272,000 budget appropriation in Urban STBGP revenues for the said project; and
- 8. Approve a \$1,430,620 budget appropriation in PTMISEA (EDCTA) revenues for the said project; and
- 9. Approve a \$837,000 budget appropriation in El Dorado Irrigation District revenues for the said project; and
- 10. Authorize City Staff to release construction contract documents for public bidding.
