8. **DISCUSSION ITEMS:**
  - A. **Review outline and proposal to implement Strategy 6.1:**

**Convene a Health and Wellness community roundtable to discuss the possibility of a focused effort to expand and diversify the health and wellness offerings in Placerville. Member Wager** gave a report on the status. Project is on hold at this time.

- B. **Strategy 4.1 Through the use of the Buxton ID Program, identify and prioritize retail businesses for location or expansion.** (This item was moved after Item 8.D.)  
Mr. Morris gave an update and provided the Committee with initial report "Insight Market Analytics "prepared by HDL EconSolutions for Committee review. Mr. Morris stated that the funding included money for Barry Foster to do some economic consulting work including looking at the Carriage Trade Shopping Center on upper Broadway.

- C. **Review and make recommendations to propose City of Placerville Website Visitors Page.** Attached is a draft of the proposed page on the City’s website to assist visitors to Placerville in planning their day.

**Committee members** commented that the map is of very low quality and that the map should not be the first item a user sees. This website needs “bling” and pictures such as the Bell Tower. The website does not draw attention.

**Member Wager** stated that the City needs to continue with the Business Outreach Program. This program allows the City to respond to business issues that are expressed by the owners.

- D. **Housing Update – Ridge at Orchard Hill, Cedar Bluffs-Unit 1, Astoria Residential Subdivision, Cottonwood Units 4 & 6, and Lumsden Ranch property.** Mr. Rivas gave an update on the status of these projects.
- E. **Member Brent-Bumb** reported that the County of El Dorado renewed the Chamber of Commerce’s lease at 542 Main Street for another 5-year term.
