Subject: Adopt a resolution authorizing the Placerville Police Department to receive excess federal property through the California Public Safety Procurement Program (CPSPP).

Discussion: The City of Placerville Police Department participates in the California Public Safety Procurement Program (CPSPP) also known as the 1033 program. The program provides California Law Enforcement Agencies access to excess federal property that is transferred pursuant to Title 10 USC § 2576a. The Department currently has equipment which requires annual recertification in the program. The Department maintains inventory controls to maintain accountability of all property and compliance with all requirements of the program.

The Department has benefitted from the program over the years to include body armor, chemical protective equipment, masks, and an aging tactical rescue vehicle provided by the program approximately 9 years ago, currently in need of replacement. The tactical rescue vehicle serves as an essential tool during tactical operations to include barricaded subjects, active shooter incidents, hostage situations, natural disasters, etc. It serves as a regional asset and is available for mutual aid responses.

To continue to retain eligibility in the program to receive excess property and be authorized to replace the current tactical rescue vehicle with more current option(s) as they become available, a resolution from the City Council is required.

Options: 1. Adopt a resolution authorizing the Placerville Police Department to receive excess federal property to include an updated tactical rescue vehicle(s) through the California Public Safety Procurement Program (CPSPP).

2. Decline continuance in the program.

Cost: There is a cost savings provided by the program whereby the police department can continue to acquire needed equipment at no cost due to it being declared excess property and transferred by the California Public Safety Procurement Program (CPSPP).

Budget Impact: None.

Recommendation: Adopt a resolution authorizing the Placerville Police Department to receive excess federal property through the California Public Safety Procurement Program (CPSPP).
