# 8. RECOMMENDATION(S) TO THE CITY COUNCIL FOR FISCAL YEAR 2012/2013 (Mr. Warren):

The Staff Liaison summarized the forecasted Measure H sales tax revenues available in Fiscal Year 2012/2013 and the uses for such revenues as discussed by the Committee. Following the Staff Liaison's comments, the Committee discussed its recommendations to the City Council for Fiscal Year 2012/2013.

Following discussion by the Committee, it was moved by Alternate Committee Member Edwards and seconded by Vice-Chairperson Cumpston to adopt the following recommendations to the City Council for the use of Measure H sales tax revenues in Fiscal Year 2012/2013:

- 1. Continue the sewer charge discounts as approved by City Council Resolution No. 7919; and
- 2. Appropriate approximately \$208,721 for other water and sewer capital improvement program projects to be determined by the City's Director of Community Development and Engineering or his designee, and
- 3. Establish an \$80,000 Operating Reserve.
