# 6. LIQUIDATION AND REAPPROPRIATION OF \$200,000 OF MEASURE H SALES TAX REVENUE FOR THE PARDI LANE/BIG CUT ROAD/SACRAMENTO STREET WATERLINE REPLACEMENT PROJECT, CIP #41109 (Mr. Stong):

- 3. Appropriate approximately \$288,721 for other water and sewer capital improvement program projects to be determined by the City's Director of Community Development and Engineering or his designee.
