**New Business – DOG PARK FENCE** – Funds raised by members of the Lindsborg Dog Park Committee now total over \$7,200. With the City budgeted match of \$7,500, members of the committee want to begin construction of fencing at the proposed sited located next to the Recycle Center. Betty Nelson moved to approve the proposal from Dellinger Fence Co. in the amount of \$11,809, which includes the City match of \$7,500) to construct Phase 1 of the Scentral Bark Dog Park Fence. Motion seconded by David Higbee and passed unanimously by roll call vote.

**SLUDGE WAGON TIRES** - The tires on the Nuhn sludge wagon which is used to haul liquid sludge are due for replacement this year. These tires have tremendous loading weight and because of the tight turning radius within the WWTP are subject to wear. This set of tires have held up well for the conditions they are subject to and were last replaced in early 2014. Blaine Heble moved to approve the purchase of 4 tires from Rod's Tire & Service for \$6247.48. Motion seconded by Rick Martin and passed unanimously by roll call vote.
