12 COMMISSIONER ROGERS: Here.

13 MADAM CLERK: Commissioner Tucci is absent  
14 excused.

15 MADAM CLERK: Commissioner Evans?

16 COMMISSIONER EVANS: Here.

17 MADAM CLERK: Commissioner Petracco is absent  
18 excused.

19 MADAM CLERK: Mayor Scarpelli?

20 MAYOR SCARPELLI: Here.

21 MADAM CLERK: Thank you.

22 All present, Mayor, except for Commissioner Tucci  
23 and Commissioner Petracco. They are absent excused.

24 MAYOR SCARPELLI: All right.

25 Commissioner Evans, what do you have on the agenda

1       tonight?

2               COMMISSIONER EVANS: I need an executive for  
3 contract negotiations (indiscernible). I have one resolution  
4 for just property tax (indiscernible) tax

22 MAYOR SCARPELLI: Aye.


