2 MAYOR PETRACCO: Madam Clerk?

3 MADAM CLERK: Yes, Mayor. Board of commissioners
4 public meeting Tuesday, June 2nd, 2015. The time is now
5 7:32.

6 Pursuant to the requirements of the Open Public

4 MADAM CLERK: Total payroll, \$780,241.69, for a
5 grand total of \$4,062,728.55.

6 COMMISSIONER EVANS: Move the bills.

18 COMMISSIONER EVANS: Yes, I have a public hearing
19 tonight for 3308, which was an amendment of an ordinance to
20 delete and add a handicapped parking spot on Lovell Court.

21 MAYOR PETRACCO: Is there anyone here this evening
22 that would like to address the board of commissioners on
23 ordinance number 3308?

24 Seeing no one, --

25 COMMISSIONER EVANS: Close the public hearing.

1 COMMISSIONER SCARPELLI: Second.

2 MADAM CLERK: Commissioner Rogers?

3 COMMISSIONER ROGERS: Aye.

4 MADAM CLERK: Commissioner Tucci?

5 COMMISSIONER TUCCI: Aye.

6 MADAM CLERK: Commissioner Evans?

7 COMMISSIONER EVANS: Aye.

8 MADAM CLERK: Commissioner Scarpelli?

12 Move the ordinance.

13 COMMISSIONER SCARPELLI: Second.

18 MADAM CLERK: Commissioner Evans?

24 Okay. Commissioner Evans, you have also the

25 budget?

1 COMMISSIONER EVANS: Yes, so tonight we have two
2 things to do tonight. One is to amend the budget to
3 recognize the increase in aid we received from the state.
4 And then, second is to actually adopt the 2015 budget.

5 So I'll first read the amendment, which says,
6 WHEREAS, the municipal budget for the year 2015 was approved
7 on the 17th day of March, 2015;

8 WHEREAS, the public hearing on said budget was
9 held as advertised; and

10 WHEREAS, it is desired to amend said approved
11 budget.

12 NOW, THEREFORE, BE IT RESOLVED by the governing
13 body of the township of Nutley, of the county of Essex,
14 state of New Jersey that the following amendment approved
15 budget be made.

16 Total general revenues from \$54,263,671 to
17 \$54,432,202 and general appropriation from \$54,263,671 to
18 \$54,432,202.

19 Before we vote this, we need to have a public
20 hearing related to the amendment only. The amendment here
21 is to increase our aid from roughly 5.2 million to 5.5
22 million.

23 MAYOR PETRACCO: Okay. Thank you.

24 Is there anyone this evening that would like to
25 address the board of commissioners on resolution number 171-

1 15?

2 MS. LANDRY: Penny Landry, 135 Lakeside Drive.

3 So, Mayor, the increase in the state aid was how much?

4 MAYOR PETRACCO: I'll let Commissioner Evans
5 answer that for you.

6 COMMISSIONER EVANS: It was from roughly 5 million
7 -- this is for the transitional aid portion.

8 MS. LANDRY: Correct.

9 COMMISSIONER EVANS: Increasing from roughly 5.2
10 million to a total of 5.5 million. So roughly a \$300,000
11 (indiscernible).

12 MS. LANDRY: A \$300,000 increase?

13 COMMISSIONER EVANS: Correct.

14 MS. LANDRY: And what was the original ask?

15 COMMISSIONER EVANS: We originally asked for 6.2
16 million. We were allowed at the time of the original
17 adoption of our budget to anticipate 85 percent of that as
18 it's an ongoing negotiation. Upon review of our budget,
19 considering the increase in the assessable values that came
20 from added assessments, the number was reconciled to 5.5
21 million.

22 MS. LANDRY: Which was a \$300,000 increase --

23 COMMISSIONER EVANS: Increase, additional
24 increase.

25 MS. LANDRY: -- over the anticipated 85 percent?

1 COMMISSIONER EVANS: Right. But if you take the
2 gross increase year-over-year, that's actually \$2,750,000.

3 MS. LANDRY: From last year?

4 COMMISSIONER EVANS: From last year.

5 MS. LANDRY: And this is transitional aid related
6 to Roche, which as I understand, is based upon the three-
7 year projection of loss in values. And what are
8 anticipating for 2016 in loss of value?

9 COMMISSIONER EVANS: Don't know that yet.

10 MS. LANDRY: Okay. Thank you.

11 MAYOR PETRACCO: Is there anyone else that would
12 like to comment on this ordinance? I'm sorry. Resolution.

13 COMMISSIONER EVANS: Move to close the public
14 hearing.

15 COMMISSIONER ROGERS: Second.

16 MADAM CLERK: Commissioner Rogers?

17 COMMISSIONER ROGERS: Aye.

6 following amendment of the approved budget be made.

7 So move.

8 COMMISSIONER TUCCI: Second.

9 MADAM CLERK: Commissioner Rogers?

10 COMMISSIONER ROGERS: Aye.

11 MADAM CLERK: Commissioner Tucci?

12 COMMISSIONER TUCCI: Aye.

25 COMMISSIONER EVANS: I got it. I got it. So

1 tonight, now that we've recognized the increase in state
2 aid, we need to move to adopt our budget for 2015. It's
3 been previously advertised. We previously hosted a public
4 hearing on that. So tonight we just need to move on the
5 vote of the budget.

6 BE IT RESOLVED by the governing body of the
7 township of Nutley, county of Essex that the budget herein
8 set before us is hereby adopted and shall constitute an
9 appropriation for the purposes stated of the sums therein
10 set forth as appropriations and authorization of the amount
11 of \$36,909,843.44 for the municipal purposes and
12 \$1,211,193,56 for the library.

13 So move.

14 COMMISSIONER ROGERS: Second.

15 MADAM CLERK: Commissioner Rogers?

16 COMMISSIONER ROGERS: Aye.

17 MADAM CLERK: Commissioner Tucci?

18 COMMISSIONER TUCCI: Aye.

7 COMMISSIONER ROGERS: Thank you, Mayor. I'm
8 calling resolution number 166-15 this evening on to 167-15.
9 I move to reappoint Annmarie Nicolette as certified deputy
10 municipal registrar effective June 5th, 2015 through
11 June 5th, 2018.

12 So move.

13 COMMISSIONER SCARPELLI: Second.

14 MADAM CLERK: Commissioner Rogers?

15 COMMISSIONER ROGERS: Aye.

16 MADAM CLERK: Commissioner Tucci?

17 COMMISSIONER TUCCI: Aye.

18 MADAM CLERK: Commissioner Evans?

19 COMMISSIONER EVANS: Aye.

20 MADAM CLERK: Commissioner Scarpelli?

2 So move.

3 COMMISSIONER SCARPELLI: Second.

4 MADAM CLERK: Commissioner Rogers?

5 COMMISSIONER ROGERS: Aye.

6 MADAM CLERK: Commissioner Tucci?

7 COMMISSIONER TUCCI: Aye.

8 MADAM CLERK: Commissioner Evans?

9 COMMISSIONER EVANS: Aye.

10 MADAM CLERK: Commissioner Scarpelli?

14 COMMISSIONER ROGERS: Resolution number 169-15,

15 WHEREAS, the township of Nutley has applied for a grant in
16 the amount of \$6,505 through Partners for Health and Shaping
17 New Jersey from which funds will be used to offset the costs
18 of printing informational material, pledge forms, and
19 advertising banners as well as the purchase of car magnets,
20 which are intended to be a visual reminder for both drivers
21 and pedestrians alike emphasizing the importance of safe
22 driving and pedestrian habits;

23 NOW, THEREFORE, BE IT RESOLVED that the mayor and
24 commissioners of the township of Nutley in the county of
25 Essex, state of New Jersey formally approves the grant

1 application for the Nutley Pace Car and Pedestrian Education
2 Program for the term of March 2015 through December 2015.

3 BE IT FURTHER RESOLVED that the mayor and clerk
4 are hereby authorized to sign the grant agreement on behalf
5 of the township of Nutley and that their signature
6 constitutes acceptance of the terms and conditions of the
7 grant agreement and approve the execution of the grant
8 agreement.

9 So move.

10 COMMISSIONER SCARPELLI: Second.

11 MADAM CLERK: Commissioner Rogers?

12 COMMISSIONER ROGERS: Before I vote, I'd like to
13 explain that this is a very, very important program that has
14 been put together by the Department of Public Health and
15 Department of Public Safety. The mayor has worked very,
16 very hard -- and we've seen the signs all over town -- to
17 increase awareness of pedestrian safety.

18 It's a problem not only here in Nutley. It's a
19 problem around the state. But he's been trying to be very
20 proactive and getting police cars out there, signs out
21 there, officers out there. And we still have the problem.

22 So the Department of Health -- we've been able,
23 through our department, to get a grant that'll help him as
24 well as us.

25 So, Mayor, it's a daunting task we have, but we

1 have the money now that may be able to give this a good
2 boost.

3 And I vote aye.

4 MADAM CLERK: Commissioner Tucci?

5 COMMISSIONER TUCCI: Aye.

6 MADAM CLERK: Commissioner Evans?

7 COMMISSIONER EVANS: Aye.

8 MADAM CLERK: Commissioner Scarpelli?

12 couple comments. It's really good when we could work
13 together on these types of projects. And it's really good
14 government when you share services like this.

15 So I want to thank Commissioner Rogers for all
16 your efforts in tracking down that grant and, you know,
17 crossing the streets in Nutley -- we've really made a really
18 good effort to slow this traffic down by enforcing the speed
19 limits around town. This month, we had click it or ticket.

20 We've had the pedestrian crosswalks with help with
21 the sheriff's department in the county. And it seems like
22 when the cops disappear, the people go back to their old
23 habits. So it's a good team effort, Commissioner, and I
24 applaud your efforts. Thank you.

25 And I vote aye.

1 Okay. I have a couple resolutions.

2 WHEREAS, sealed bids for furnishing and delivering
3 police dispatchers and crossing guard uniforms and equipment
4 were publicly opened and read on May 20th, 2015; and

5 WHEREAS, Turnout Uniforms is the lowest bidder;
6 and

7 WHEREAS, the funds in the amount of \$48,000 are
8 available in an appropriation entitled 5-01-310-200, "Police
9 and Dispatcher Maintenance & Allowance," and the funds in
10 the amount of \$5,700 are available in appropriation entitled
11 5-01-308-200, "Crossing Guards Allowance," and have been
12 certified by chief financial officer, said certification
13 being attached to this resolution;

14 NOW, THEREFORE, BE IT RESOLVED by the board of
15 commissioners of the township of Nutley, county of Essex,
16 state of New Jersey that a contract furnishing and
17 delivering police, dispatchers, and crossing guard uniforms
18 and equipment, consistent with the 2015 clothing voucher
19 allocation, be and is hereby awarded to Turnout Uniforms,
20 195 Patterson Avenue, Little Falls, New Jersey.

21 I move the resolution.

15 WHEREAS, the applications have been reviewed and
16 approved by the municipal clerk and the police department;

17 NOW, THEREFORE, BE IT RESOLVED by the board of
18 commissioners of the township of Nutley, county of Essex,
19 state of New Jersey that the aforementioned licenses are
20 approved and the municipal clerk is authorized to issue the
21 licenses.

22 I move the resolution.

23 COMMISSIONER TUCCI: Second.

9 Thank you. That concludes our business portion of
10 the meeting.

11 Before we open the meeting up, I think this is the
12 Barr (ph) family here this evening, and I think I've gotten
13 a few emails from them. And I have to thank my assistant,
14 Sam Carella, for working with you guys on this. So we have
15 a proclamation for your daughter, and I'll be glad to read
16 it.

17 WHEREAS, Tourette Syndrome (TS) is an inherited
18 neurological disorder that is characterized by involuntary
19 physical and vocal tics that occur many times a day;
20 and

21 WHEREAS, Tourette Syndrome is often accompanied by
22 other conditions such as attention deficit and obsessive
23 compulsive disorder, learning disabilities, and
24 depression; and

25

1 WHEREAS, the neurological disorder known as
2 "Tourette Syndrome" (TS) affects 1 in 100 children. More
3 than 20,000 school age children in the State of New Jersey
4 alone are dealing with TS, and although some of these cases
5 are aided by medication, there is no standard treatment or
6 known cure for this disorder; and

7 WHEREAS, there is an important need for more
8 professional help with interest and expertise to identify,
9 counsel and treat people with TS, with the lag time between
10 initial onset of symptoms and proper diagnosis for those who
11 do seek help still averaging more than seven years; and

12 WHEREAS, positive actions to assist those children
13 and families dealing with TS would result from a broadening
14 of public and professional knowledge and acceptance of TS;
15 and

16 WHEREAS, the New Jersey Center for Tourette
17 Syndrome is the first and only program of its kind in the
18 nation, and they are actively providing services to
19 families, educating medical professionals, teachers, social
20 workers and supporting research to understand the signs and
21 treatments of TS; and

22 NOW, THEREFORE, BE IT RESOLVED by the board of
23 commissioners, township of Nutley, county of Essex, State of
24 New Jersey, that Thursday, June 4, 2015 will be recognized
25 as "Tourette Syndrome Awareness Day" in, as a special

1 day to promote understanding, compassion, and acceptance for
2 all of our fellow citizens who deserve and need our support
3 to break the stigma that is related to Tourette Syndrome.

4 So with that being said, we don't need a vote for
5 a proclamation. I would just like to say congratulations to
6 you for having the courage and the fight to do what you do
7 every day.

8 I could assure you the board of commissioners are
9 very proud of you. And here in Nutley, we don't want to see
10 any of our children with any kind of disabilities or
11 sicknesses.

12 So it's my pleasure and honor to call this day
13 Tourette Syndrome Day and bring awareness to it.

14 Commissioners, would you like to join in?

15 Commissioner Scarpelli?

16 No?

17 Steve?

18 COMMISSIONER ROGERS: That's fine, Mayor. You
19 said it all.

20 UNIDENTIFIED SPEAKER: No, Mayor.

21 MAYOR PETRACCO: Okay. Can we bring the family
22 up, and we'll take a little snapshot?

23 (Applause)

24 (Pause)

25 MAYOR PETRACCO: Don't be nervous.

1 (Pause)

2 MADAM CLERK: All righty.

3 MAYOR PETRACCO: Okay. Please just state your
4 name and address for the record.

5 MS. T. BARR: Tara Barr, 23 Edison Avenue.

6 MAYOR PETRACCO: Okay. What would you like to
7 tell us?

8 MS. T. BARR: Thank you.

9 MAYOR PETRACCO: Anything else?

10 MS. T. BARR: (Indiscernible).

11 MAYOR PETRACCO: Mom, would you like to say
12 something?

13 MS. BARR: This is hard.

14 MAYOR PETRACCO: It's hard. And we realize that,
15 and we're very proud of you. And I know that Nutley offers
16 a lot of things, and you could always feel free to come to
17 your board of commissioners, your board of education if you
18 have a problem.

19 If you see us in the street, always tell us what
20 your needs are, and we'll be there for you. That's a
21 promise. Okay? Thank you.

22 And let's hear it for the young lady.

23 (Applause)

24 MAYOR PETRACCO: Okay. Just hold on one second.
25 Sam wants to talk to you guys before you leave.

1 That concludes our business portion of the
2 meeting.

3 Is there anyone here this evening that would like
4 to address the board of commissioners?

5 Please state your name and address for the record.

6 MS. LANDRY: Pennie Landry, 135 Lakeside Drive,
7 Nutley. The 2015 municipal budget -- what will be the total
8 tax rate this year, including the library rate, total tax
9 rate assessed to homeowners?

10 MAYOR PETRACCO: Commissioner Evans?

11 COMMISSIONER EVANS: The 2015 rate would be \$1 and
12 about 18 cents. It's actually 1.178.

13 MS. LANDRY: 1.178?

14 COMMISSIONER EVANS: Correct.

15 MS. LANDRY: And the 2014 rate was 1.116.

16 COMMISSIONER EVANS: 1.15 -- oh, excuse me. No,
17 it would be 1.153.

18 MS. LANDRY: 1.153. So we've gone from 1.153 to
19 1.178. And what will that be per taxpayer on 315,000?

20 COMMISSIONER EVANS: \$88.

21 MS. LANDRY: \$88 for the municipal portion. And
22 what was the rate for the Board of Education?

23 COMMISSIONER EVANS: 1.595.

24 MS. LANDRY: 1.595. And what does that equate to
25 for 315,000?

1 COMMISSIONER EVANS: \$113.80.

2 MS. LANDRY: 113 plus 88. So that gives us 819.

3 COMMISSIONER EVANS: 83.

4 MS. LANDRY: Excuse me?

5 COMMISSIONER EVANS: 113.83. And the exact amount
6 for the municipal is 88.12.

7 MS. LANDRY: 88.12 plus 113. So we're looking at
8 200 and approximately 1 dollars in property tax increase for
9 every \$315,000 of property value, correct?

10 COMMISSIONER EVANS: You also have the county.

11 MS. LANDRY: And what will that be?

12 COMMISSIONER EVANS: That rate is .544.

13 MS. LANDRY: And what --

14 COMMISSIONER EVANS: It's decreasing from .557.
15 And that's a \$47.74 decrease. So the --

16 MS. LANDRY: What's the total for this year?

17 COMMISSIONER EVANS: Roughly \$154.

18 MS. LANDRY: So \$201 plus \$154.

19 COMMISSIONER EVANS: No, no, no, no, no.

20 MS. LANDRY: Is that the total?

21 COMMISSIONER EVANS: The total is 154. It's 201
22 minus 47, 48. And then, you get down to the 154.

23 MS. LANDRY: Okay. So the county went down?

24 COMMISSIONER EVANS: Correct.

25 MS. LANDRY: But the municipal went up, and the

1 Board of Ed. went up?

2 COMMISSIONER EVANS: Correct.

3 MS. LANDRY: Okay. So what was that total again?
4 I'm sorry.

5 COMMISSIONER EVANS: Roughly \$154.

6 MS. LANDRY: \$154 tax increase for every \$315,000
7 in property value?

8 COMMISSIONER EVANS: Correct.

9 MS. LANDRY: Okay. I want to acknowledge and
10 thank those of you who had decreases in your departments.
11 They are appreciated.

12 Because, as you know, the tax burden is
13 significant in the town. And I know that keeping the level
14 of services that we have here is extremely important.

15 I do have two questions, if I could be allowed
16 those two questions?

17 MAYOR PETRACCO: Sure.

18 MS. LANDRY: Okay. Thanks.

19 The treasurer's office -- how many staff members
20 are in the treasurer's office?

21 COMMISSIONER EVANS: Treasurer's office includes
22 purchasing, tax collector, cashiers as well as the accounts
23 that are in department. So right now, that's three, five,
24 eight.

25 MS. LANDRY: Eight employees?

1 COMMISSIONER EVANS: Correct.

2 MS. LANDRY: Eight staff members in the
3 treasurer's office with a budget line item of \$466,000 in
4 salaries.

5 COMMISSIONER EVANS: Uh-huh.

6 MS. LANDRY: Okay.

7 The other question I have is that we had an
8 increase in salaries for the administration of township
9 ordinances. How many employees come under the
10 administration of township ordinances? It's salaries for
11 administration of township ordinances.

12 COMMISSIONER EVANS: Yeah, that's split. Well,
13 you have a construction official. You have a zoning
14 official. You have three other people that are full-time
15 plus a full-time building inspector then part-time
16 electrical, fire safety, and plumbing inspectors.

17 MS. LANDRY: And they come under administration of
18 township ordinance? The construction official, the zoning
19 official --

20 COMMISSIONER EVANS: Yeah, I don't have the detail
21 in front of me. I don't know what the split is, but that's
22 everybody who's up there.

23 MS. LANDRY: Okay.

24 COMMISSIONER EVANS: So if you take the people --

25 MS. LANDRY: And you're saying that their salaries

1 are split with some other department?

2 COMMISSIONER EVANS: No, they're into two groups.
3 I just don't have the budget line items split to say this
4 person's in this particular group, this person's in the
5 other. Because you have the administration of township
6 ordinances, and you have the construction office. So I
7 don't know the exact split off the top of my head as it's
8 allocated in the budget.

9 MS. LANDRY: And when you say split, what do you
10 mean? Because I didn't see construction office line item.
11 They had administration of township ordinances. Do you all
12 have a copy of the budget here, given that --

13 COMMISSIONER EVANS: No, I didn't bring it
14 tonight, because we already had a public hearing on the
15 budget. So I don't have the budget with me tonight. We
16 were only doing amendment.

17 MS. LANDRY: All right. Well, we had an increase
18 from 255 to 295 for administration of township ordinances.
19 And could you give some detail as to why there was a \$40,000
20 increase in that area?

21 COMMISSIONER EVANS: Part of it would be salary
22 increases. Plus, we added a part-time building inspector.

23 MS. LANDRY: You added a part-time inspector?
24 Okay. Building inspector?

25 COMMISSIONER EVANS: Yes.

1 MS. LANDRY: And so, his salary was roughly
2 \$40,000 is what you're saying?

3 COMMISSIONER EVANS: Well, no, not his alone. I
4 said -- you asked me for the increase. I said salary
5 increases, plus there's a head count.

6 MS. LANDRY: Okay. All right.

7 And the final question is the township clerk's
8 office -- how many staff members are in the township clerk's
9 office?

10 COMMISSIONER EVANS: Three.

11 MS. LANDRY: Three? And could you explain why
12 there was an increase from 154 to 160?

13 COMMISSIONER EVANS: Because one of those
14 employees was actually in the tax assessor's office in last
15 year's budget, and they were moved from the assessor's
16 budget to the clerk's office, where they're now working.

17 MS. LANDRY: Okay. So we have three people in the
18 township clerk's office, and one was moved from the
19 assessor's office?

20 COMMISSIONER EVANS: Uh-huh.

21 MS. LANDRY: And last year, we had two people in
22 the clerk's office?

23 COMMISSIONER EVANS: Two and a half.

24 MS. LANDRY: Two and a half? And now, we have
25 three? Okay. Thank you.

1 COMMISSIONER EVANS: Okay. And I want to thank
2 you, because my budget went down year-over-year. So thank
3 you for recognizing that.

4 MS. LANDRY: I recognized everybody. I don't
5 recognize salary increases, though, as a benefit to all of
6 the township (indiscernible).

7 I guess the last thing I want to say is when you
8 guys look around the room at the number of people that are
9 here, I would just hope that when you're out in town and
10 talking to people that you encourage them to get a little
11 more involved and to be here and learn about what's going on
12 here.

13 MAYOR PETRACCO: I see many, many people a day.

14 MS. LANDRY: No, it's really just --

15 MAYOR PETRACCO: And I always encourage them to
16 get involved.

17 MS. LANDRY: Thank you.

18 MAYOR PETRACCO: Or all the organizations in town,
19 you know, not just here. But it's good --

20 MS. LANDRY: No, it's just really discouraging to
21 see an empty room week after week after week after week.

22 MAYOR PETRACCO: Well, I could tell you -- when
23 we've had some big issues in town that I've had in public
24 safety, this room has been filled in and out.

25 MS. LANDRY: Yeah, I know.

1 MAYOR PETRACCO: So, you know, I have to say when
2 you don't see too many people here -- and I know that
3 they're televised -- it kind of gives me a good feeling that
4 we're doing a pretty good job. Can we always do better and
5 strive for the best? Absolutely. But it's --

6 MS. LANDRY: That's one way to look at it.

7 MAYOR PETRACCO: Yeah, but it's refreshing --

8 MS. LANDRY: Okay.

9 MAYOR PETRACCO: -- that if people -- one thing
10 about Nutley people I could assure you. If they have a
11 problem, they come out, and they speak their minds, and we
12 embrace it.

13 So at this point, if that's it tonight -- because
14 we just want --

15 MS. LANDRY: That's it. Thank you.

16 MAYOR PETRACCO: Yeah.

17 MS. LANDRY: You all have a great evening.

18 MAYOR PETRACCO: You, too. Thank you, Ms. Landry.

19 I guess we can move to close.

20 COMMISSIONER SCARPELLI: Move to adjourn.

21 MAYOR PETRACCO: Commissioner Rogers?

22 MADAM CLERK: Commissioner Rogers?

23 COMMISSIONER ROGERS: Before we adjourn, --

24 MADAM CLERK: Oh, I'm sorry.

25 COMMISSIONER ROGERS: About walking around town,

1 seeing people, and talking to them, do that every day, every
2 day, almost 100 people a day visiting homes and talking to
3 people of all ages. The one thing I'm hearing is that they
4 want our services maintained. They love this town. They
5 love the stability of this governing body.

6 You don't hear that much in other communities. A
7 lot of pride in this town. They're concerned about taxes,
8 yes, as anybody is. The five of us are concerned about
9 that.

10 But they know darn well that the services in this
11 town are second to none in the state of New Jersey. And if
12 you were to ask me to prioritize a list of the things that
13 they are truly concerned about, they want their streets
14 safe. They want their parks clean.

15 Commissioner Evans, they know your background, and
16 they scratch their heads sometimes saying, "What are you
17 doing here?" You know? And I've always said to gentleman
18 Joe, "You're doing a great job cleaning these streets."

19 So they are pleased with living in Nutley. And I
20 hope to God that whether it's us or younger people in the
21 future that take over, they follow our lead to do the job to
22 the best of their ability like we have. So when the people
23 are telling you that when you're out on the streets and
24 we're knocking on doors without any, any preempting them and
25 they're just offering those things up, I guess they're

1 saying, "Thanks a lot, fellas. Appreciate it."

2 I vote aye to close the meeting.

3 MAYOR PETRACCO: Thank you, Commissioner.

4 MADAM CLERK: Commissioner Tucci?

5 COMMISSIONER TUCCI: Aye.

6 MADAM CLERK: Commissioner Evans?

7 COMMISSIONER EVANS: Aye.

8 MADAM CLERK: Commissioner Scarpelli?

9 COMMISSIONER SCARPELLI: Aye.

10 MADAM CLERK: Mayor Petracco?

11 MAYOR PETRACCO: Aye.

12 Have a good evening.

13 MADAM CLERK: The time is now 8:05.






