WHEREAS, it is in the best interest of the Township of Nutley to continue to utilize the services of the Township of Montclair for furnishing of health services to cover the period of January 1, 2008 to December 31, 2008 for a fee of \$7,798.00 per calendar quarter in 2008, \$8,032.00 per calendar quarter in 2009 and \$8,273.00 per calendar quarter in 2010.
