A RESOLUTION ACCEPTING FEDERAL FUNDING FROM THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT, ADMINISTERED BY THE STATE OF NEW JERSEY, DEPARTMENT OF LAW AND PUBLIC SAFETY, DIVISION OF CRIMINAL JUSTICE FOR THE SOLE PURPOSE OF PURCHASING BODY WORN CAMERAS.

WHEREAS, the Township of Nutley Police Department submitted an application on November 30, 2016 to the State of New Jersey, Department of Law and Public Safety for the 2016 Body Worn Camera (BWC) Assistance Program for assistance in purchasing, not to exceed, 30 Body Worn Camera packages through the Edward Byrne Memorial Justice Assistance Grant; and

WHEREAS, on January 9, 2017, the Township of Nutley received written notification from the State of New Jersey, Department of Law and Public Safety of an award of \$15,000.00 (not to exceed \$500.00 per camera) for the Township Police Department to use towards the purchase, not to exceed, 30 Body Worn Camera Packages under award number: JAGBWC22-16; and

WHEREAS, the Township of Nutley Police Department has a period of performance from January 9, 2017 through January 8, 2018 to purchase said Body Worn Camera Packages and provide for full payment of any balance for the purchase, not to exceed, 30 Body Worn Camera Packages in excess of the approved \$15,000.00 funding; and
