Zoning (Codes) and Planning – (Councilman Messa)

<u>Sherrillbrook Park rezoning – Local Law Introductory "B" of 2018</u>

WHEREAS, on March 7, 2018, the Town Board declared itself as Lead Agency in this matter to correct the zoning classification of Sherrillbrook Park from PR (Parks and Recreation) and LDR (Low Density Residential) so that the entire Park is zoned PR; and

WHEREAS, on March 7, 2018, the Town Board referred this zoning matter to the Town Planning Board, Oneida County Planning Department, and involved/interested agencies for GM-239 review and SEQR review and comment; and

WHEREAS, the Town has received various comments from the aforesaid Departments and involved/interested agencies;

Going forward, when a developer meets with the Codes Enforcement Officer for the first time to review plans, the developer would enter into a contract with the Town and start paying for engineering fees. Codes Enforcement Officer Booth has drafted legislation which has been reviewed by the Town Attorney. Codes Officer Booth clarified that the new procedure would apply to commercial projects, large subdivisions, but not for the typical homeowner.

RESOLUTION OF THE TOWN BOARD OF THE TOWN OF NEW HARTFORD AUTHORIZING THE LEASE OF REAL PROPERTY LOCATED OFF OF NEW PARIS ROAD (ROUTE 12) AND ISSUING A NEGATIVE DECLARATION PURSUANT TO THE NEW YORK STATE ENVIRONMENTAL QUALITY REVIEW ACT ("SEQRA")

WHEREAS, the Town was presented with an offer from Homeland Towers, LLC ("Lessee") to enter into an Option and Ground Lease Agreement for a portion of the real property located off of New Paris Road (Route 12), in the Town of New Hartford, designated as APN Tax I.D. Number 338.000-3-4 (the "Property"), for the placement of equipment, building(s) and a tower for the purpose of constructing, establishing and maintaining a "cellular" transmission tower facility for Lessee's use and that of its subtenants, licensees and customers; and

WHEREAS, the Town Board has determined to lease the Property for adequate consideration of no less than fair market value without the services of a real estate broker; and

WHEREAS, in exchange for granting Lessee a 12 month option to lease the Property, Lessee shall pay the Town and Option fee equal to \$2,000.00; and

WHEREAS, Lessee shall have the right to extend the option for One (1) additional twelve (12) month period by providing the Town with written notice of its intent to extend the option, which notice will be accompanied by an additional option fee payment of \$100.00; and

WHEREAS, LESSEE shall also have the right to request to extend the Option for one (1) additional twelve (12) month period ("Second <u>Extension Period</u>") with LESSOR consent, which consent shall not be unreasonably denied. LESSEE must give written request for the Second Extension Period prior to the end of the then-current Option Period, accompanied by an additional option fee payment of One Thousand and 00/100 Dollars (\$1000.00) (the "Second Additional Option Fee")

WHEREAS, the base rent for the Property shall be \$1,400.00 per month or twenty percent (20%) of the gross income derived by Lessee from its subtenants, licensees and customers using the telecommunications facility, whichever is greater, for an initial term of 10 years; and

WHEREAS, the Town Board believes that the lease of the real property is in the public interest of the residents of the Town, particularly since the end result will be more efficient cellular telephone communications within the Town; and

WHEREAS, the Town Board preliminary classifies this action as an unlisted action under SEQRA, and determines that it will act as the Lead Agency with respect to the environmental review of the proposed lease of the Property in accordance with SEQRA and Part 617 of the regulations implementing SEQRA; and

WHEREAS, the execution of the Option and Ground Lease Agreement for the Property is subject to: (1) a permissive referendum pursuant to Section 64, Subdivision 2 of the New York State Town Law; (2) the issuance of a negative declaration pursuant to SEQRA, and (3) the review and approval of the Option and Ground Lease Agreement as to form and content by the Attorney for the Town; and

WHEREAS, the Town Board has reviewed the Short Form Environmental Assessment Form ("EAF") prepared for this action;

NOW, THEREFORE, BE IT HEREBY

RESOLVED, that the Town Board of the Town of New Hartford hereby determines that the project is an unlisted action pursuant to Part 617 of the regulations implementing SEQRA and that the Town Board shall act as Lead Agency for the required environmental review; and it is further

RESOLVED, that the Town Board determines that the Option and Ground Lease Agreement and the construction and operation of the communications tower and related facilities will have no significant adverse impacts on the environment, and hereby issues a negative declaration for the proposed Project and authorizes the Supervisor of the Town of New Hartford to execute Pages 3 and 4 of the EAF; and it is further

RESOLVED, that pursuant to the provisions of Section 64, Subdivision 2 of the Town Law of the State of New York, the Town Board does adopt this Resolution agreeing to enter into an Option and Ground Lease Agreement for the Property for not less than its fair market value; and it is further TOWN BOARD MEETING May 2, 2018 Page 10 of 13

RESOLVED, that this Resolution is adopted subject to a permissive referendum and that the Town Clerk is directed to publish and post the notice of adoption of this Resolution in accordance with Article 7 of the Town Law; and it is further

Sewer Fund Payback Schedule

In November 2016 the Town Board voted to pay back the Sewer Fund \$75,000 per year for a ten (10) year period and made one (1) \$75,000 payment in 2017. Discussion now ensued whether to adjust the payback amount with Councilman Messa introducing the following Resolution; seconded by Councilman Cittadino:

(RESOLUTION NO. 188 OF 2018)

WHEREAS, on November 9, 2016, the New Hartford Town Board adopted Resolution No. 181-B to establish a plan to reimburse the Sewer Fund for monies owed and that said plan shall be annual payments of \$75,000 over a ten (10) year period, during the first quarter of each year beginning January 1, 2017;

NOW, THEREFORE, BE IT RESOLVED that the New Hartford Town Board does hereby adjust the Sewer Fund Payback Schedule established in November 2016 so that effective in 2018 the payback will be Twenty-five Thousand Dollars (\$25,000) per year; further, the Town Board shall review this schedule from time to time for possible increase in payments.

<u>Speed limit reduction – Status; Snowden Hill Road</u>

Councilman Messa questioned the status of his December 2017 inquiry for a lower speed limit along a section of Snowden Hill Road. [Note: At the December 13, 2017 Town Board meeting, the Police Chief stated that a traffic study would need to be done by the NYS Department of Transportation, and that he would request the traffic study.] The TOWN BOARD MEETING May 2, 2018 Page 12 of 13

Town Clerk recalled that a particular form is necessary to initiate the study (TE 9a) jointly with the Oneida County Department of Public Works. With regard to School Bus signs, the Highway Superintendent informed Councilman Messa that he could help in the proper placement of such signs.

<u>Street Lights – Routes 5 – 8- 12- 840</u>

Councilman Reynolds initiated discussion on the issue of lights at the Routes 5, 8, 12, and 840 interchange, and more particularly the lack of lights. Those lights have been out for an extended period of time, and he thought at one time the City of Utica did not want to pay for the lights anymore and had them shut off. Although he is aware the lights are owned by the City, the City's action affects the Town of New Hartford. Councilman Reynolds believes the Town should petition the City to activate the lights because this is a high traffic area and a high accident area.

The Highway Superintendent provided information that the NYS Department of Transportation would be making changes in that specific interchange, including lighting, in next year's projects.
