# Zone Map Amendment Application – George Koury; Local Law Introductory "D" of 2014

The Town Clerk acknowledged receipt of SEQR comments from various agencies with regard to George Koury's application to rezone approximately 6.5 acres located at 31 Clinton Road, New Hartford from Medium Density Residential (MDR) to High Density Residential (HDR) for the purpose of constructing a (four) 4 building apartment complex with six (6) units per building. On April 18, 2014 the Town Planning Board submitted their recommendation that the Town Board not accept Mr. Koury's application due to concerns in relation to the slopes, drainage and spot zoning as well as many discrepancies and that the application is inadequate. The Town Attorney stated that Mr. Koury has the right to a public hearing; Councilman Woodland then introduced the following legislation for the Town Board's consideration at a future Public Hearing, co-sponsored by Councilman Miscione:

# TOWN OF NEW HARTFORD, NEW YORK LOCAL LAW INTRODUCTORY "D" OF 2014

A Local Law to amend the Code of the Town of New Hartford, **Chapter 118** thereof entitled **ZONING**, and map coincidental thereto, as it pertains to property located at 31 Clinton Road (aka NYS Route 12B), a description of which is set forth in Section 2, and changing the designation of property from MDR (Medium Density Residential) to HDR (High Density Residential).

**BE IT ENACTED** by the Town Board of the Town of New Hartford as follows:

<u>Section 1.</u> Chapter 118 of the Code of the Town of New Hartford, Section 118-8, and particularly the map coincidental thereto and made a part thereof, is hereby amended as follows:

Section 118-8. Zoning Map.

(Change the designation of six point five [6.5] acres, more or less, situate at 31 Clinton Road and identified as Tax Map Parcel No. 328.016-4-62, owned by George T. Koury II, from MDR [Medium Density Residential] to HDR [High Density Residential.])

A Local Law to amend the Code of the Town of New Hartford, Chapter 107B thereof entitled TELECOMMUNICATIONS FACILITIES in the Town of New Hartford.

BE IT ENACTED by the Town Board of the Town of New Hartford as follows:

<u>Section 1.</u> Chapter 107B of the Code of the Town of New Hartford, Section 107B-5 is hereby amended by adding the following:

### E. Collocated/existing structure antennas.

An antenna that is to be attached to an existing communications tower or any other structure is a permitted use in all zoning districts, except in or within 750 feet of a residential zone. An antenna that is to be attached to any other structure in any zone, other than a residential zone or within 750 feet of a residential zone, is a permitted use. These antennas are permitted upon the issuance of a building permit. The building permit application will include a structural analysis/report verifying the ability of the structure to support the antenna while also deeming the structure to be capable of supporting the additional loads. The height of the antenna shall not extend above the height of the existing structure by more than 50 feet.

<u>Section 2.</u> All other provisions of Chapter 107B of the Code of the Town of New Hartford, and amendments thereto, are hereby affirmed except to the extent that this Local Law shall modify or amend.

<u>Section 3.</u> This Local Law shall become effective immediately upon its filing with the Office of Secretary of State.
