# A RESOLUTION OF THE TOWN OF NEW HARTFORD ADOPTING THE 2013 UPDATE OF THE ONEIDA COUNTY HAZARD MITIGATION PLAN.

**WHEREAS**, the Town of New Hartford recognizes the threat that natural hazards pose to people and property within the Town of New Hartford; and

**WHEREAS**, the Town of New Hartford, with the assistance of the Oneida County Soil and Water Conservation District has gathered information and prepared the Oneida County Hazard Mitigation Plan Update; and

**WHEREAS**, the 2013 Update to the Oneida County Hazard Mitigation Plan identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in the Town of New Hartford from the impacts of future hazards and disasters; and

WHEREAS, adoption by the Town of New Hartford demonstrates our commitment to the hazard mitigation and achieving the goals outlined in the 2013 Update to the Oneida County Hazard Mitigation Plan; and

**WHEREAS**, the 2013 Oneida County Hazard Mitigation Plan Update has been prepared in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS, the Town of New Hartford is a local unit of government that has afford the citizens an opportunity to comment and provide input in the Plan and the actions in the Plan; and

**WHEREAS**, the Town Board has reviewed the Plan and affirms that the Plan will be updated no less than every 5 years;

**NOW, THEREFORE, BE IT RESOLVED** by the New Hartford Town Board that the Town of New Hartford adopts the Oneida County Hazard Mitigation Plan as this jurisdiction's Natural Hazard Mitigation Plan, and resolves to execute the actions in the Plan.

**RESOLVED** that the Town Board of the Town of New Hartford does hereby authorize and direct the Town Supervisor and Highway Superintendent to execute the 2014 Roadside Ditching Agreement and Addendum between the Town of New Hartford and the County of Oneida acting through the Oneida County Department of Public Works wherein said Town agrees to furnish some machinery and labor to the County for the purpose of providing the County with roadside ditching services to keep Right of Way portions of the highway ditched in accordance with the rules and regulations as set forth by the County, which rules and regulations are made a part of said Agreement for the construction season dating from May 1, 2014, through December 1, 2014.

The Town Attorney stated that the proposed Agreement was the same as in 2013. Thereafter, a roll call vote was duly held:

**RESOLVED** that the New Hartford Town Board does hereby authorize and direct the Town Superintendent of Highways and the Town Supervisor to enter into and to execute an Agreement with the County of Oneida, by and through Dennis S. Davis, Commissioner, County Department of Public Works, 6000 Airport Road, Oriskany, New York, for the control of snow and ice on County Roads for the Snow Season dating from November 1, 2014, through April 30, 2016, and as more fully set forth in an Agreement to be filed in the New Hartford Town Clerk's Office. The County shall pay the Town the sum of \$5,800 per mile for the duration of this Agreement, covering 20.19 miles of county roads.

The Highway Superintendent noted that this Agreement provides for a Three Hundred Dollar (\$300) increase per mile over the last Agreement. Thereafter, upon roll call, the Town Board voted as follows:

#### Agreement / Training for One-man Plowing

The Highway Superintendent presented a proposed Agreement between the Town and Mohawk Valley Community College (MVCC) for one-man plowing instruction for 23 Highway Department employees. The cost of the training program would offset personnel expenses if the snowplows were using wingmen. The employees who attend the training would become certified and would need a refresher course in the future; new employees would be required to attend training upon employment. Discussion included whether a Town employee could be certified to teach other Highway Department employees in-house. Councilman Reynolds suggested that it might be beneficial to the Town to have a third-party instructor. Thereafter, Councilman Messa introduced the following Resolution for adoption; Councilman Woodland seconded same:

#### Councilman Messa

#### Abandoned/dilapidated properties

Councilman Messa has received phone calls from Beechwood Road residents, complaining about the condition of 44 Beechwood Road, including holes in the roof. Upon request of Councilman Messa, Codes Enforcement Officer Joseph Booth brought forth photos of various properties. As this property and others involve court cases, the Town Attorney requested that these matters be held for Executive Session.

#### Property (Lawn) maintenance Fees

The question had arisen whether the Town is reimbursed for its costs in providing lawn maintenance when properties are abandoned. The Finance Director had confirmed that the Town's expenses are sent by the Town Codes Department to Oneida County Finance and then appear on the Town and County tax bills categorized as "unpaid miscellaneous." The Town Supervisor acknowledged that the Town is made whole at the end of the tax collection period.

#### Councilman Miscione

#### <u>Certiorari – Yahnundasis vs Town of New Hartford / Retain attorney</u>

Councilman Miscione suggested that the Town Board hire Attorney Dan Vincelette to represent the Town in the Yahnundasis certiorari against the Town. Town Attorney Cully stated that Attorney Vincelette had handled the Preswick Glen litigation in the past

and the Town received a very favorable result. Further, that in past certiorari matters involving the New Hartford Central School District, there was an arrangement whereby the School District selected the attorney and paid 90% of the costs, while the Town paid 10%. Assessor Abatecolla confirmed that most of the Yahnundasis property was in the New Hartford Central School District while a smaller parcel consisting of vacant land is situated in the New York Mills Union Free School District. Thereafter, Councilman Miscione introduced the following Resolution for adoption; seconded by Councilman Reynolds:

#### (**RESOLUTION NO. 193 OF 2014**)

**RESOLVED** that the Town Board of the Town of New Hartford does hereby retain attorney Dan Vincelette to represent said Town in the Yahnundasis certiorari vs the Town of New Hartford subject to Town Attorney Herbert Cully confirming whether or not any arrangements can be made for sharing fees.

The Town Board voted upon roll call as follows:

The Resolution was declared unanimously carried and duly *ADOPTED*.

#### Systems Development Group (SDG – software)

Councilman Miscione is looking to have a program that the Assessor and Codes Offices can use and be accessible to one another. He didn't know whether the SDG software was web-based but thought if it were, the Town Clerk's office might be able to access information as well. He quoted initial start-up costs for the "add on" to the existing program at \$1200 per department and thereafter, a \$1200 annual maintenance fee. The Town Supervisor noted that the Town had looked into this and budgeted funds a couple years ago. He asked that Councilman Miscione verify the fees quoted, check into some demo's and keep in touch/work with Deputy Supervisor Matthew Bohn on this proposal.

#### Town Attorney

#### **Kessler Litigation**

The Town Attorney had provided the Board members with copies of the Court's decision in the matter of the Kessler case, wherein the Town was sued, and it was asserted that the Town Board didn't have the right to refuse to accept the dedication of a road. Attorney

Cully read, in part, from the Judge's decision "...the Town cannot be compelled to accept a private road and neither a Town Superintendent of Highways or a Planning Board may bind a municipality to accept a proper dedication absent the Town's consent...." Further, the Court found that the "...Town Board's decision was based upon numerous facts...", with reference to the video of the February 12, 2014, Town Board meeting; "the Supervisor and Town Board members were concerned that after major storms, water flows from Whitestown to the property containing the proposed road; floods the area. The problem is that the Oneida County pipes below the development are too small to handle the water flow and the Board members acknowledge that the subject development of the road was not the cause of the flooding and the petitioner has done a lot to mitigate. The articulated concern was that the site would continue to flood after major storms and that the Town would be liable." The Court's finding is that the Town Board's failure to accept the petitioner's private road for dedication was within its discretion. The Town Attorney advised that any Board comments should be held for Executive Session.

# <u>Oneida County Flood Mitigation Grant Program: Municipality – SWCD Contract for</u> <u>Implementation of BMPs: Chapman Road and Grange Hill Road</u>

The Town Supervisor reported that the Highway Superintendent has been working on two (2) stormwater projects and has been working with the Oneida County Soil and Water Conservation District for assistance. The first is on upper Chapman Road where it is proposed to install a culvert trash rack and stream stabilization and funding assistance is available through Oneida County. Thereafter, Councilman Messa introduced the following Resolution for adoption; Councilman Reynolds seconded same:

#### (RESOLUTION NO. 194 OF 2014)

RESOLVED that the New Hartford Town Board does hereby authorize and direct the Town Supervisor to enter into and to execute a contract between the Oneida County Soil and Water Conservation District ("District") and the Town of New Hartford ("Municipality") for the purpose of installing a Curb Trash Rack & Stream Stabilization as Best Management Practices (BMP) specified in the Oneida County Flood Mitigation Grant Program; this contract establishes the responsibilities of the District and the Municipality and/or Operator, and provides for procedures for disbursement of the Oneida County Flood Mitigation Grant Program funds.

The Agreement provides that the "Municipality" will provide 50% of the cost of these installations up to a limit of \$20,000 cash or in-kind contribution. Subject to the availability of funds, the "District" will obligate sufficient funds to cover BMP implementation costs not to exceed \$18,000 (50% of the BMP Implementation cost) in county funds. Thereafter, the Town Board voted upon roll call:

The second project involves Grange Hill Road where two (2) detention ponds are being considered for installation uphill. The Town has worked well with the contractor and detention ponds. It was suggested that the ponds at the top of the road be done as Phase I. And get the contractor and Highway Department crews on-site. The bottom portion probably will need engineering work and the Town would have to obtain permits from NYS Department of Environmental Conservation permits and the Army Corps of Engineers and possibly go to bid. Councilman Miscione offered the following Resolution for adoption; Councilman Messa seconded same:

#### (**RESOLUTION NO. 195 OF 2014**)

**RESOLVED** that the New Hartford Town Board does hereby authorize and direct the Town Supervisor to enter into and to execute a contract between the **Oneida County Soil and Water Conservation District ("District")** and the **Town of New Hartford ("Municipality")** for the purpose of installing **Storm Detention Basins** as Best Management Practices (BMP) specified in the Oneida County Flood Mitigation Grant Program; this contract establishes the responsibilities of the District and the Municipality and/or Operator and provides for procedures for disbursement of the Oneida County Flood Mitigation Grant Program funds.

It is expected that the projects will begin during the current year. The Agreement provides that the "Municipality" will provide 50% of the cost of these installations up to a limit of \$100,000 cash or in-kind contribution. Subject to the availability of funds, the "District" will obligate sufficient funds to cover BMP implementation costs not to exceed \$18,000 (50% of the BMP Implementation cost) in county funds.
