CALL TO ORDER:

Mayor Tim Wilson called the meeting to order at 7:00 p.m. and led the Pledge of Allegiance.

Police Chief Dunnagan swore in new police officer Todd Gilbert.

PUBLIC HEARING ON THE 6 YEAR STREET PLAN

Mayor Wilson opened the public hearing at 7:04 p.m. City Administrator Ehman Sheldon explained the purpose of a 6 year street plan, noting the importance to have street projects listed on the plan to meet requirements of some funding opportunities. He reviewed the projects on the proposed plan. Mayor Wilson asked for public comments. Sean Bates, 1156 E. Juniper Street, asked about the Scooteny Street west across the railroad tracts project; how it would affect the topography due to the fact that it currently has a 3'-5' drop in elevation. Mr. Sheldon asked for an opportunity to look at the drop off before responding. Mayor Wilson asked for Council comments. Councilmember Johnson asked what the City's responsibility would be for the turn lane and approaches on SR 24. Mr. Sheldon advised the project is to construct a center turn lane and approaches on SR 24. There have been meetings with local businesses and the City would be responsible to construct the radiuses. Mayor Wilson closed the public hearing at 7:12 p.m.

REVIEW OF 14TH AVENUE FUNDING

City Engineer Larry Julius advised that the Council recently included the 14th Avenue reconstruction project on the list of projects seeking funding through the Public Works Trust Fund (PWTF) loan program. Staff has identified 14th Avenue from north of Cemetery Road to SR 26 as an arterial and they recommend that it be built to City arterial street standards. It will include two lanes, a center lane and parking lanes. It is estimated that the construction of the center turn lane in this portion of 14th Avenue to SR 26 will be \$200,000. He asked whether the City would participate in paying for the center turn lane construction or require the various property owners on both sides of 14th Avenue to pay the costs. He noted that the City is not required to financially participate although there have been a couple developments where the City has participated in a portion of the costs for a center turn lane. Mr. Sheldon advised that the adjacent property owners have asked what their cost portion will be. Councilmember Dorow asked if there are provisions in an ordinance relevant to the City's participation. Mr. Sheldon indicated that it is a policy decision.

SCOOTENY STREET & 7TH AVENUE INTERSECTION STUDY

Police Chief Dunnagan advised that due to the new building developments near Scooteny Street and South 7th Avenue, there are increases to the volumes of vehicles and pedestrians. He reported that they have reviewed the intersection of East Scooteny Street and South 7th Avenue relevant to revision of the traffic flow through the intersection and recommend installing four-way stop signs. A traffic study was completed by the City Engineers. They also recommend removing the free right-turn sign and removing the traffic island.

MONTHLY INVESTMENT REPORT

Finance Officer Mike Bailey gave a report on the status and performance of the City's investments in the Local Government Investment Pool and the financial portfolio with the Bank of America. He also noted that he will be doing some research for interest rates.

NEW BUSINESS

Mayor Wilson made the following announcements:

• The pool opens Saturday, June 9th.

- Healthy Communities will meet noon on Wednesday, June 6th at the Adams County Services building.
- The quarterly Regional Adams County Mayors luncheon will be Wednesday, June 13th at the Othello Senior Center.
