



**FIRST ADDENDUM TO AMENDED INTERLOCAL AGREEMENT BETWEEN THE  
CITY OF OTHELLO AND ADAMS COUNTY REGARDING RCW 39.34.180**

THIS ADDENDUM is entered into this 9<sup>th</sup> day of <sup>February, 2015</sup> ~~December~~, 2014, by and between Adams County, a political subdivision of the State of Washington, and the City of Othello, a municipal corporation, and shall be effective beginning January 1, 2015.

**WHEREAS**, Adams County and the City of Othello entered into an Amended Interlocal Agreement regarding RCW 39.34.180 on January 18, 2011.

**WHEREAS**, Section 4.3 D requires the convening of an annual review committee to determine the need for any changes or revisions to the said Interlocal Agreement.

**WHEREAS**, the parties met in July 2014 and agreed upon one (1) small change to the terms of the said Interlocal Agreement.

**NOW THEREFORE**, the parties hereby agree as follows:

1. The Interlocal Agreement dated January 18, 2011 shall remain in effect.
2. Paragraph 4.2 E is hereby revised to reflect as follows:

The City shall be responsible for all medical costs of City Misdemeanants pursuant to RCW 70.48.130. In emergency or life threatening situations the County will provide transportation and or security up to, two hours, unless other arrangements have been made between the City and County. In non-emergency situations the County will consult with the City as to the place and means of treatment of City Misdemeanants, for those inmates who demonstrate no apparent ability to pay their own medical costs. The City will be responsible for all transportation and security needs.


3. All other terms and conditions of the said Interlocal Agreement shall remain unmodified.




