 - 9. WARRANTS REDEEMED TO FUND ACCOUNTING;
 - 10. MANUALS; and,

It is further agreed and understood that the required materials and instruction to City personnel are not yet .. completed, and all software will not be required to be on the maintenance contract until said time as final acceptance of completion of said contract has been finalized; and,

It is further agreed and understood that Gary Sippel will be scheduled to work at least two (2) full days each week at the City of Othello until above work is completed by COMPUTER SERVICES BUREAU OF MOSES LAKE, INC.
