

**RESOLUTION NO. 91-06****A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OTHELLO, WASHINGTON FIXING A TIME AND DATE FOR A HEARING ON THE FINAL ASSESSMENT ROLL FOR LOCAL IMPROVEMENT DISTRICT NO. 16.**

WHEREAS, the City Council of the City of Othello, Washington (the "City" adopted Resolution No. 89-03 on April 10, 1989, declaring its intention to or certain local improvements within the City and to create a local improvermer district; and

WHEREAS, a hearing was held on May 8, 1989 and after due consideration th Council passed Ordinance No. 801 on May 8, 1989, ordering the improvements an crating Local. Improvement District No. 16 ("LID No. 16"); and

All persons who may desire to object to such improvements at hereby notified to appear and present such objections at such hearing, with the dat of 'the first publication to be at least 15 days prior to the date of said hearing, and t mail a notice of such hearing at least 15 days before the date thereof, to each own( or reputed owner of any lot, tract, parcel of land, or other property in LID No. 16, the address shown on the tax rolls of the Adams County Treasurer.
