## RESOLUTION NO. 2007-20

## A RESOLUTION AUTHORIZING USE OF CITY PROPERTY AND PUBLIC RIGHT-OF-WAY FOR THE OTHELLO SUN FAIRE EVENTS TO BE HELD ON WEDNESDAY JULY 4, 2007

## **RECITALS:**

- I. The Othello Sun Faire Committee of the Greater Othello Chamber of Commerce has organized the Sun Faire festival to be held on Wednesday July 4<sup>th</sup>, 2007. The fireworks display will also occur on July 4, 2007.
- 2. The City of Othello endorses and supports the Othello Sun Faire activities.

## **RESOLVED:**

- 1. The Othello Sun Faire shall be allowed to use public park property and identified streets for the community related activities: flag raising; food booths; vendors; exhibits; sporting events; children's games; family entertainment; fireworks display; 3 on 3 basket ball tournaments, and related family activities at Lions Park. A 5K and 10K Sun-Run, and a parade are also scheduled to be upon and utilizing city streets. The Sun Faire committee is scheduling other events for the pleasure of our citizens and visitors.
- 2. The City Council approves street barricading for the parade, Sun Run and other Sun Faire activities, as requested by the Othello Sun Faire. A parade and street use permit application has been completed by the Sun Faire Committee for the events and has been reviewed by the Police Department, Public Works and Fire District. Responsibility for obtaining and returning the barricades shall remain with the Othello Sun Faire committee.
- 3. The City shall absorb in-kind financial expenses for Public Works and Police services, street sweeping, porta-potties, and solid waste dumping fees. These services will be absorbed by the City and are considered additional expenses of city services during the period the Sun Faire activities takes place.
- 4. If there are any special requests to supply water, it will be the decision of the Public Works Department as to how that water will be obtained.
- 5. Overnight vendor parking in the form of motor homes or campers, shall be permitted to take place in the city park parking lots during the designated date of the Othello Sun Faire festival (July 3rd and 4th). The City of Othello will not provide extra Police security services for those overnight accommodations.
- 6. Parking shall be prohibited along parts of the parade route on July 4, 2007 for a period of time determined necessary by the Othello Police Chief or his designee and the Othello Sun Faire committee.

- 7. The Greater Othello Chamber of Commerce shall provide a copy of a liability insurance certificate in the amount of no less than \$1,000,000 per occurrence and \$2,000,000 aggregate, with the City of Othello being named as an additional insured.
- 8. The Greater Othello Chamber of Commerce shall execute a Facility Use Agreement for all Sun Faire related activities.
