

RESOLUTION NO. 2014- 01

A RESOLUTION ESTABLISHING AN AMENDMENT TO THE  
RATE SECTION OF THE AGREEMENT BETWEEN THE  
CITY OF OTHELLO AND ADAMS COUNTY WATER  
DISTRICT NO. 1 FOR WATER SUPPLY

**Recitals:**

1. There is an agreement between the City of Othello and Adams County Water District No. 1 for water supply dated June 14, 1982.
2. The agreement provides that if the proposed rate changes are agreed to by the Othello City Council and the Water District Commissioners, the same shall be adopted in the form of resolutions by the City Council and the Water District Commissioners.

**Resolved:**

1. Section V (1) of said agreement is modified to read as follows:

- (1) The DISTRICT agrees to pay the CITY at the rates listed in the following schedule for each ONE HUNDRED cubic feet (100 c.f.) of water metered monthly, effective as follows, listed in the columns titled **2014, 2015, and 2016:**

(1 unit = 100 cubic feet of water)

Charges for the water volume rate will be charged on the total water metered through the 8" water meter for water usage within the Adams County Water District boundaries.

2. Section V (2) is modified to read as follows:

- (2) The DISTRICT agrees to pay a minimum monthly service charge according to the following schedule, effective as follows, which is the minimum monthly service charge for a 6" meter located outside of the corporate limits:


The above stated rate schedules shall be in effect from the date of execution of this

amendment and commensurate with the City's water billing of January 16, 2014; and shall remain in effect thereafter until increased or decreased by subsequent amendment to this agreement.

Except as the same may have been specifically modified as set forth above, all other terms and conditions of the agreement shall remain in full force and effect.
