A RESOLUTION AMENDING RESOLUTION 2014-3 AUTHORIZING USE OF CITY
PROPERTY FOR THE COMPASSION EXPERIENCE CHANGE THE STORY PRESENTATION
SCHEDULED FOR MAY 30, 2014 THROUGH JUNE 3, 2014

RECITALS:

1. Representatives of the Othello Christian Church have coordinated the Compassion Experience Change the Story presentation and Sunday worship service, scheduled for Friday, May 30th, 2014 through Tuesday, June 3rd, 2014.
2. The Othello Christian Church is committed to promoting a community-wide, family-friendly event open that is open to the public.
3. The Othello Christian Church is non-profit organization

RESOLVED:

1. The Othello Christian Church and its representatives shall be permitted to use the City owned gravel lot property on 9th Avenue and Pine Street for this presentation. Setup shall take place on Friday, May 30th, 2014 from 8:00 AM to 9:00 PM. The presentation shall be held Saturday, May 31st, 2014 from 9:00 AM to 9:00 PM, Sunday, June 1st, 2014 from 9:00 AM to 9:00 PM and Monday, June 2nd, 2014 from 9:00 AM to 9:00 PM. Cleanup shall take place on Tuesday, June 3rd, 2014 from 8:00 AM to 1:00 PM.
2. The Othello Christian Church and its representatives shall be permitted to use Lions Park for a worship service in coordination with this event. Setup shall take place on Sunday, June 1st, 2014 from 8:00 AM to 10:00 AM. The worship service shall be held Sunday, June 1st, 2014 from 10:00 AM to 11:30 AM, followed by a picnic from 11:30 AM to 1:00 PM. Cleanup shall take place on Sunday, June 1st, 2014 from 1:00 PM to 3:00 PM.
3. The Othello Christian Church shall pay the Special Event Fee of two-hundred dollars (\$200) for use of City property, due to the anticipated event attendance of 150-500 people. Payment of the Special Event Fee will allow Public Works to supplement the fees incurred to provide additional garbage containers, as well as cover the landfill fees for waste disposal.
4. If there are any special requests to supply water, it shall be the decision of the Public Works Director, or his designee, as to how water shall be obtained.
5. The Othello Christian Church and its representatives shall be responsible for any damage to City property as a result of use and shall be required to pay the cost of any replacement equipment, cleaning or repair, including City of Othello personnel time at the cost of time and materials, as determined by the Public Works Director.
6. The Othello Christian Church and its representatives shall provide liability insurance in the amount of no less than \$1,000,000 per occurrence and \$2,000,000 per aggregate with the City of Othello named as an additional insured. The City shall receive a copy of the insurance and endorsement certificates prior to the event/presentation date.
7. The Othello Christian Church and its representatives shall enter into and execute a Facility Use and Indemnification Agreement with the City of Othello.
